We are in receipt of your communication (PS-1) (EDB-1), which requests:

"May I please request a status report of all vacant positions, as of March 15, 2019, by position number and division, within each department or office. The report should include the status of the vacancy, the Equivalent Personnel count assigned, and the estimated annual salary for each position. If applicable, indicate how long the position has been vacant."

The attached report shows the vacant positions by department, by division. Also indicated are the annual salaries for the vacant positions and the date that the position was last filled. With regard to the current status, please refer to the Report of Action column.

Please note that this information is based on the data stored in our current human resources information system. That system stores information regarding positions as they currently exist, rather than as they were budgeted, so the information presented may vary from the budgeted values. For example, the FTE and the annual pay reflect the currently established defaults for the position, and may not directly correspond to the budgeted EP and annual salary.
