SUBJECT: FISCAL YEAR ("FY") 2020 BUDGET (PR-6) (EDB-1)

The following is our Department's response to requests from the April 3, 2019 correspondence:

1. Relating to page 12-12 of the Budget Details (index code 915019B, subobject code 6155 Towing Charges), explain why the \$50,000 for countywide towing, storage, and disposal of unclaimed vehicles are not charged to the Department of Environmental Management. (KK)

We currently coordinate with the Maui Police Department and the Department of Environmental Management on abandoned vehicles within any of our parks or facilities. The requested \$50,000 for countywide towing, storage, and if necessary, disposal of unclaimed vehicles would cover vehicles that are not

qualified, or not determined, to be abandoned by the Department of Environmental Management but are still impacting our parks or facilities hence requiring immediate action. Some examples of these types of vehicles would be vehicles impeding ingress and/or egress, parked in loading zones or accessible stalls, or vehicles that have been left in parks or facilities for a duration of more than 48 hours and are creating an unsafe environment.

2. Provide a breakdown on the revenue generated from Waiehu Municipal Golf Course operations for FY 2019, to date. (KK)

Revenue generated from the Waiehu Municipal Golf Course operations for FY 2019, to date is as follows:

Revenue from Playing Fees (Green Fees) \$584,734 Revenue from Pro Shop Concession \$122,250

3. Relating to page 12-36 of the Budget Details (Parks Program, Parks Beautification, index code 915680C, sub-object code 7105), clarify whether the lease amount of \$80,005 for large rotary mowers represents the amount paid per year or the total amount paid for five years, of the lease. (KK)

The \$80,005 is the annual lease amount for six (6) large rotary mowers utilized department wide. This lease agreement commenced in 2016.

4. Explain why a Planner position is proposed to be moved from the Parks Program to the Administration Program. (KK)

The Planner VI position is under the Administration Program's organizational structure. The Department had the intention of submitting a reorganization to move it to the Parks Program under the Planning division. It was found that the Chief of Planning has a salary equivalency to the Planner VI's salary range and would not be able to supervise this position. Therefore, the reorganization was not submitted and the position was put back in the FY 2020 proposed budget to its current program.

5. Provide a status update on the Lanai Skateboard Park project. If additional funding is needed for completion, provide that amount. (RH)

The Lanai Skateboard Park project is on hold pending location of a suitable site for the facility. Additional funding will be needed for design and construction once a site has been selected. Until such time, we are unable to provide an estimate on the amount of funding needed for completion of the

project. It would depend on land entitlement requirements, the existing topography of a proposed location, and the availability of infrastructure nearby, as well as other criteria.

6. Provide a status update on the Lanai Youth Center project. If additional funding is needed for completion, provide that amount. (RH)

The Lanai Youth Center project is also pending site selection, preferably near the proposed skate park. Our Department is working with the Department of Housing and Human Concerns as a grant was awarded to the Lanai Youth Center for planning and design of a new facility.

7. Relating to CBS-3232, Countywide Park Playground Improvements (page 743 of the Program Budget), provide an itemized list of proposed projects for FY 2020, in order of priority, and include the estimated cost per project. (MM)

Please see attached Exhibit #1 of proposed projects for FY 2020, in order of priority, including estimated cost per project.

8. Relating to CBS-4581, Countywide Parks Facilities (page 744 of the Program Budget), provide an itemized list of proposed projects for FY 2020, in order of priority, and include the estimated cost per project. (MM)

The purpose of this request is to have funds available to keep projects moving when small unforeseen situations occur. Contingency funds are normal and necessary in the implementation of capital improvement projects, both during design and permitting as well as during construction. As the use of these funds is contingent on unforeseen circumstances, it is not possible, at this time, to provide an itemized estimate of cost per project.

9. Relating to CBS-4613, Countywide Light Ordinance Compliance (page 745 of the Program Budget), provide a list of all park facilities, structures, and fields that are non-compliant. Attach a schedule of the proposed work to be completed and anticipated completion dates. (MM)

Please see attached Exhibit #2 listing all park facilities, structures, and fields that are non-compliant including the proposed work to be completed and anticipated completion dates.

10. Relating to CBS-2340, Makawao-Pukalani-Kula-Ulupalakuka Parks System (page 755 of the Program Budget), provide an itemized list of proposed projects for FY 2020, in order of priority, and include the estimated cost per project. Provide a list of projects completed, a status update on projects in progress, and a cost breakdown of expenditures for FY 2019, to date. (MM)

Please see attached Exhibit #3. Regarding FY 2019 expenditures to date, \$350,457.80 has been encumbered on the Upcountry Swimming Pool Complex Structural Repairs project which is anticipated to be completed in May 2019. Once that project is completed, it is intended that the balance of funds in that account will be applied toward design for renovations and improvements to the Eddie Tam Gym Building.

11. Relating to CBS-2348, Paia-Haiku Parks System (page 759 of the Program Budget), provide an itemized list of proposed projects for FY 2020, in order of priority, and include the estimated cost per project. Provide a list of projects completed, a status update on projects in progress, and a cost breakdown of expenditures for FY 2019, to date. (MM)

Please see attached Exhibit #4. Regarding FY 2019 expenditures to date, \$110,801 has been encumbered for planning, permitting and design for the Paia & Haiku Community Centers Restroom and Kitchen Improvements project. It is intended that the balance of funds will be utilized for the construction of the aforementioned kitchen and restroom improvements at the Haiku Community Center.

12. Relating to CBS-5056, Alfred Flako Boteilho Sr. Gym Improvements (page 760 of the Program Budget), provide a cost breakdown of the \$225,000 being requested. Provide details on the funds expended and include a status update on the work performed and yet to be completed for FY 2019, to date. (MM)

The FY 2020 funding request is for refinishing of the court hardwood floor after the roofing replacement project is completed. Funds expended from the FY 2019 appropriation were for the building plans review fee (\$1,533) and the Disability Communication Access Board (DCAB) review fee (\$2,500). The building permit is currently being processed. The project will be advertised for bids once the permit is approved and a contract for construction will then be executed.

13. Relating to CBS-1209, War Memorial Complex Paving Improvements (page 764 of the Program Budget), provide a breakdown on the \$2,750,000 being requested. Provide details on the funds expended and include a status update on the work performed and yet to be completed for FY 2019, to date. Indicate whether this project will have an impact on the proposed alternate parking plan for the Wailuku Civic Complex project. (MM)

The \$2,750,000 requested in FY 2020 is solely for the reconstruction of the parking lot serving the football and baseball stadiums and the tennis courts. None of the \$500,000 appropriated in FY 2019 has been expended as the amount of funds was inadequate. The project is fully designed and will be advertised for bids once fully funded. It is intended that the project construction schedule will be coordinated to accommodate the proposed alternate parking plan for the Wailuku Civic Complex project.
