My name is Pete Jalbert. I have been a member of the board of directors for the Paia Youth Council, Inc since 2008. The Paia Youth Council is the board for the Paia Youth and Cultural Center (PYCC). It has been an honor and privilege to help support the Youth Center's mission of "Building Community Through Youth."

PYCC depends upon the financial support of private donors, foundations, county and state funding. I want to thank the County Council for their past generosity towards the PYCC. It has been integral to the growth of the center. PYCC currently serves 75-80 youth a day. Dear Committee Members:

I am a full-time resident of the West Side of Maui. I am grateful to the Council for funding the Third Saturday Recycling program at Lahaina Cannery Mall, and hope you will consider continuing to do so.

I know that the County provided grants to Malama Maui Nui to pay some of the costs of this great recycling project, which has been so beneficial to the community, the island and the state. I also know from experience that a great number of volunteers provide the necessary labor to conduct this project from month to month.

I realize that Lahaina has an expanded recycling center on Lahainaluna Road, but they do not accept everything and many of things they won't accept, the Third Saturday Recycling will. This program has done so much to prevent the many dumpings that were significantly in view just a few short years ago. At the end of the day, the Council can support the program upfront to decrease the dumpings or they will pay the higher cost of county clean ups, pollution and unsightly views on streets, parks, vacant lots, gulches, rivers, etc. on the back end. The Council will pay one way or the other- I hope you stay in front of it!

The proposed budget presented provides less than half the funds needed by Malama Maui Nui. Unless the Council increases the funding, these events will be cut in half next year and so much of the progress made by this program will be reversed and the number of dumpings will start to increase again.

I urge the Council to increase the proposed funding and continue to support the monthly recycling events in West Maui, for everyone's sake.

The proposed budget includes a chapter entitled "Long Term Financial Plan" but it makes no mention of **two of the** county's largest long term liabilities:

- unfunded pension/retirement benefits and
- unfunded health care benefits promised to retirees.

Note the comment below from George Mason University's 2018 report on the fiscal health of each state, placing Hawaii near the bottom quartile compared to all states.

Visibility, quantification and discussion of Maui's share of unfunded pension/retiree benefits + unfunded health care benefits guaranteed to retirees should be included in this chapter with progress toward better funding identified and tracked over time.



"HAWAII SUMMARY

On the basis of its solvency in five separate categories, Hawaii ranks 38th among the US states for fiscal health. Hawaii has between 2.22 and 2.91 times the cash needed to cover short-term obligations. Revenues exceed expenses by 5 percent, with an improving net position of \$332 per capita. In the long run, Hawaii has a net asset ratio of -0.16. Long-term liabilities are higher than the national average, at 84 percent of total assets, or \$12,056 per capita. Total unfunded pension liabilities that are guaranteed to be paid are \$44.01 billion, or 61 percent of state personal income. OPEB are \$9.07 billion, or 13 percent of state personal income."

The Mauna Kahalawai chapter request that we can receive county funding to create a community driven HFUU farmers market booth which would have components of aggregating fruits and vegetables from the residential and agricultural community in our region, This includes farmers and home owners that have fruit trees and vegetables to glean from. This would also have a professional story board of the educational outreach for those to learn more about who we are and what value we bring to our agricultural and community region.

We as a chapter want to broaden our outreach to include educational workshops that lead up to our state wide convention, which brings in experts in their field of regenerative agriculture to assist in support of our farmers continuing education of living Aloha Aina Malama Aina. We already are doing this to some degree through our chapter gatherings each month that are open to the public and our existing members.

Our chapter has been in existence since 2014 and in that time we have made a name for ourselves through the support of our state organization and the community who are proud members of HFUU. Our meetings are currently held the 2nd Thursday of each month at the chef table of the Maui Tropical Plantation and we invite and encourage all of our county officials to come and be part of the abundant agricultural presence we provide as a service to our community in raising the awareness of the importance of our local food supply.

Aloha Council Member Sinenci,

The Haleakala chapter of HFUU would like to request County funding for several initiatives, as follows:

- Support for an HFUU booth at local farmer's markets. Farmers are already overworked without having to staff a booth several times a week just to sell their produce. This is particularly true of smaller farms that only grow a limited number of crops. We would like to see support in the form of a coordinator who would aggregate produce and take it to market on behalf of farmers. In my opinion, this would be best done at existing markets in town and possibly in cooperation with the Mauna Kahalawai chapter. This would also create an excellent opportunity to raise funds for the Union and grow our membership, while expanding market opportunities for farmers and making nutritious, locally grown food more available to residents.
- Create a farm labor clearinghouse, where workers can register according to their abilities and experience and be rated and certified by HFUU. Faarmers who need extra help from time to time could easily locate and confidently hire available workers with the required skills. This may be online only or include a physical location. HFUU might consider offering payroll services as an adjunct.
- Direct support for each Maui chapter. This could aid in helping cover the cost of speakers brought in from outside Maui. It could also help support new programs, like the Junior Farmer's Program of the Haleakala chapter.
- Support for the 2019 HFUU State Convention. Our annual convention has grown in quality each year and last year's was the best yet. But the comments heard most frequently have been regarding the cost. We are providing an immense value to the farming and general community but if people cannot afford to attend much of that value is being wasted. County support of this event would be a concrete demonstration of its commitment to our farming community.

Aloha Council Member Sinenci,

Thank you for considering our request for county funding. Our chapter, as well as all Maui chapters would benefit from county funding in regards to starting farmers markets in our regions to help support local farmers and the community. Also we would appreciate funding to help educate the community and other farmers with specific workshops that are available to everyone.

In addition the Hana chapter would like to do research and steps into serving the needs and opportunities of East Maui agricultural producers with mini food hubs and the cooperative transport of produce to markets on the other side of the island. Most small growers don't have the economy of scale to make it worthwhile to drive their harvest to central Maui for sale, but would be able to contribute to a regular cooperative shipment. Certain sites with existing chillers could serve as drop off locations. Refrigerator trucks that are currently bringing goods into Hana but going out empty could deliver East Maui produce to markets with relatively little additional cost, just some coordination. Another option we will research is partnering with the Mokulele airlines and Ampaire for air cargo using the hybrid-electric airplane that they will be testing in Hana.

The Hana Chapter would like to continue our Rat Lungworm Disease prevention outreach efforts. We received a grant from the Hawaii Community Foundation through the Hawaii Farmers Union Foundation in 2017, to do outreach and education with farmers and provide education for our residents. While we are fortunate that no new cases of the disease have been recently confirmed in East Maui, the disease and its vectors are here to stay and require a permanent lifestyle change. To make sure our community doesn't become complacent, we want to continue offering current education, awareness and tools for our farmers, residents and visitors regarding vector control, safe food handling, and diagnosis and treatment. We also want to be available to support other communities who may look to East Maui as a model of community-and farmer- driven response to this critical health and agricultural issue.
