May I respectfully request that you submit the below proposed proviso's for consideration for addition to the Fiscal Year 2020 Budget.

ENVIRONMENTAL MANAGEMENT-

1. CIP, CBS-1119, Countywide Environmental Protection Agency, Compliance Wastewater Reclamation Facility Renovation, PB, page 665.

"Provided that for the Kuau pump station project there shall be no disruption to traffic along Hana Hwy. during peak rush hours both in morning and afternoon."

2. CIP, CBS No-1183 and 1184, Paia-Haiku, Kuau No 3 and 4 Force Main Replacement, PB, pages 681-683.

"Provided that there is no disruption to traffic along Hana Hwy. during peak rush hours both in morning and afternoon."

FINANCE-

1. CIP, CBS-1218, Countywide Equipment, page 720, item (a) Department of Public Works, D-8 Dozer.

"Provided the D-8 Dozer will be designated for West Maui Highways Division."
