Re: Proposal to Reduce the Department of Liquor Control Airfare and Per Diem by \$50,000 (70%) and limiting travel expenses to the training of Liquor Control Enforcement Officers only by Council Member Mike Molina

Dear Chair Rawlins-Fernandez and Members,

Council Member Mike Molina, at the Economic Development and Budget Committee hearing on February 18, 2019, proposed to reduce the Liquor Commission's budget for Airfare and non-reportable Per Diem by Fifty Thousand dollars (\$50,000.00) and limiting travel expenses to the training of Liquor Control Enforcement Officers only. The proposed 70% (\$71,590-\$50,000 = \$21,590) reduction and proviso for limiting travel expenses to the training of Liquor Control Enforcement Officers only will severely impact and cripple the Department's ability to carry out its mission to protect the health, safety and welfare of the general public and to provide a safe and healthy environment for the people of Maui County. This proposal severely limits and/or eliminates its core operations, as well as, education and training programs.

Attached for your information and review are the Department's core operations and education and training programs which the reduction and proviso will greatly impact. Please be informed that Operations expenditures need to take precedent over education and training.

In regards to Council Member Molina's concerns regarding education and training opportunities for Liquor Control Officers in Enforcement only:

The Department has Liquor Control Officers in both the Enforcement and Administrative Services Divisions. The Department is also comprised of other staff members that are not Liquor Control Officers.

All staff, to include Liquor Control Officers in both the Enforcement and Administrative Services Divisions and non-Liquor Control Officers are afforded the same education and training opportunities. This provides a fair and equitable working environment. Limiting travel expenses to the training of Liquor Control Enforcement Officers only will eliminate the level playing field that should be afforded to all employees of the Department.

Liquor Control Officers are offered and have taken the training and educational classes offered to all employees by the County and have also attended other training and education opportunities that arise throughout the year.

Each Division has always been instructed to submit their wish list for additional education, training, vehicles, equipment, etc. by September of each year so it may be considered in the preparation of the yearly budget. The Enforcement Division Liquor Control Officer IV has not submitted any request in the past three cycles for any additional training or educational opportunities to be included in the budget while the Administrative Services Division Liquor Control Officers have requested and was budgeted to attend the Public Agency Training Council.

In addition, reducing and limiting travel expenses to the training of Liquor Control Enforcement Officers only will also eliminate travel for the Liquor Commission and Liquor Control Adjudication Board members to carry out and fulfil their duties and responsibilities as set forth in Hawaii Revised Statutes, County Charter, and Rules of the Liquor Commission. In closing, the Department is tasked with regulating an industry that produced over \$406 million dollars, in Maui County alone, in gross liquor sales in Fiscal Year 2018, and the numbers grows each year. As proposed in the Mayor's budget, the Department's budget is -0.3% overall. The proposed operations budget of \$441,544 is only .001% of the industry the Department is tasked with regulating on three different islands.

Also, because the Department is solely funded by liquor license fees, any reduction will not benefit another County Department. A reduction will only take away from the needs of the licensees and the community we serve.

Mahalo for your consideration and continued support in meeting our responsibilities as set forth in Hawaii Revised Statutes, County Charter and Rules of the Liquor Commission in helping to provide a safe and healthy environment for the people of Maui County.
