Mike,

I sent what I wrote below to Chair King. Had to share my mana'o, perhaps against my better judgment, because I shouldn't be involved anymore. I don't know...lol

Wong has been effectively removed i.e. "resigned". Should he have stayed, many more incriminating details would have emerged about him. However, the "old boy network" is still intact with the nomination of Moana Lutey. I just want you to know that. The Mayor is clearly resisting change. You are part of the old and the new; but, you are not corrupt. I believe that. Please understand that if you really want Maui to have a new beginning; you need to bring in a strong legal advocate who represents, as the Charter states, the laws and rules of the County as the Corporation Counsel.

Neither the County administration, nor the County residents are the Corporation Counsel's client. It is the Charter really. The Charter is being ignored, and misused to the benefit of the well connected.

We need a competent expert in island urban planning to Direct the Planning Dept. and someone strong in infrastructure, as Director of Public Works, who is not part of the developer club on Maui. They need to be competent to coordinate with expert consultants who understand development on an island and to develop appropriate infrastructure. Jordan Hart, for example, is not experienced (like Chris Hart); he is not qualified; and he is part of the "developer club".

Then, we should be developing and encouraging an Hawaiian economy through cultural and eco tourism spearheaded by the Hawaiian Community in partnership with others, supported by the County, in a way which has integrity. Tourism remains the lifeblood of the island economy, not development with 2.3 cars per household and a lack of sufficient infrastructure which is clearly outpaced by new opportunities for foreign residents.

All this can only be accomplished with a person of high moral integrity and credentials at the helm of the Corporation Counsel. That person, regrettably, is not Moana Lutey, nor any of her associate deputies.

You can't put clean fruit in a dirty bowl.

Please encourage the Mayor to build a team which reflects the best of what we can be as a pluralistic island community whose roots have always been in the Aloha, of the People of the Aina. We need to partner with the Hawaiian Community more to secure and strengthen those roots, not just exploit them. And, we need to grow an Hawaiian economy in the process.

Strengthen the roots; strengthen the tree.
