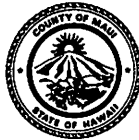

**MAUI COUNTY COUNCIL**  
**Amendment Summary Form**

**Legislation:** Fiscal Year 2020 Budget Bill – Bill 36 (2019)

**Proposer:** Council Vice-Chair Rawlins-Fernandez

**Description:** Amend page 8 of Bill 36 (2019), Department of Finance, Countywide Costs, to reflect an appropriation of the transfer in the amount of \$1,000,000 from the General Fund to the Experimental and Demonstration Housing Projects Fund, Category B. Reduce the Category B total by \$1,000,000 for the Department of Finance, Countywide Costs, Post-Employment Obligations.

**Motion:** Move to amend:

- 1) Page 8 of Bill 36 (2019), Department of Finance, Countywide Costs, by inserting a line to reflect the addition of funding to the Experimental and Demonstration Housing Projects Fund, Category B, by transferring \$1,000,000 from the General Fund.
- 2) Page 8 of Bill 36 (2019), Department of Finance, Countywide Costs, Post-Employment Obligations, by reducing the Category B total by \$1,000,000.

**Effect:** See attached marked-up copy.

**Reasons:** The Economic Development and Budget Committee voted to appropriate funding in the amount of 1,000,000 to the Experimental and Demonstration Housing Projects Fund. This is reflected in Appendix A-II. This amendment is a housekeeping matter to reflect transfer voted on by the Committee, reflected in Appendix A-II.
