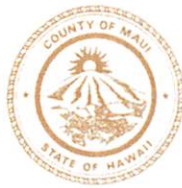

- 2) **Project Name:** Maui Lani Sand Hill Estates
- 3) **Purpose:** For Underground Sewerline Purposes, including Manholes and other equipment and appurtenance necessary or expedient for the proper maintenance, operation or repair of such underground sewer pipelines.
- 4) **Dedication:** Sewer system improvements consisting of an existing 8-inch PVC pipe sewerline installed in 2004. All of the sewer system improvements have been confirmed to be located within stated easement areas.
- 5) **Conformance:** Easement locations and widths are acceptable to the Department of Environmental Management and are in conformance with County standards.

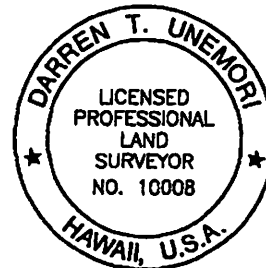

**Description of Easement S-2
(Sewerline Easement)**

A Sewerline Easement S-2 in favor of the County of Maui, affecting a portion of R.P. 1996, L.C. Aw. 420 to Kuihelani, also affecting all of Lot 109 of Sandhills Estates (File Plan 2404) at Wailuku, Maui, Hawaii and being more particularly described as follows:

Beginning at a point at the northwesterly corner of this easement, being also the southwesterly corner of Lot 24 of Sandhills Estates (File Plan 2404), the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being 1,913.09 feet North and 528.88 feet East and running by azimuths measured clockwise from True South:

1. 261° 17' 154.07 feet along Lot 24 of Sandhills Estates (File Plan 2404);
2. 352° 30' 30.01 feet along Lot 110 (Keonelo Street) of Sandhills Estates (File Plan 2404);
3. 81° 17' 153.43 feet along Lot 23 of Sandhills Estates (File Plan 2404);
4. 171° 17' 30.00 feet along Lots 71 and 96 of Hale Koa (File Plan 413) to the point of beginning and containing an Area of 4,613 Square Feet.
