Victorino notified the Council that he nominated Kaulana Mossman to the Liquor Control Commission for the County of Maui for a term expiring March 31, 2023, to fill a vacancy replacing Jonathan Todd, pursuant to Sections 8-13.2 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Kaulana Mossman to serve on the Liquor Control Commission for the County of Maui for a term expiring March 31, 2023; and
2. That the Council expresses its gratitude and appreciation to Kaulana Mossman for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
