A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.44, MAUI COUNTY CODE, RELATING TO BOND COVERAGE FOR MEMBERS AND SUBORDINATES OF THE MAUI REDEVELOPMENT AGENCY

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 2.44, Maui County Code, is amended be adding a

new section to be appropriately designated and to read as follows:

ODDINANCE NO

"2.44.040 Maui redevelopment agency bond coverage. The director of finance shall procure a bond for the members, and subordinates, if required of the Maui redevelopment agency to satisfy the requirements of section 53-2, Hawaii Revised Statues."
