Dear Chair Paltin:

We are in receipt of your letter dated May 2, 2019 regarding the subject project. We offer the following responses to your questions:

1. The Committee discussed the Waiale Road Extension. A proposed Condition of Zoning will require the landowners of the project to contribute a pro rata share to the extension from Waiko Road to Honoapiilani Highway. Will their contribution help expedite the extension's construction?

A pro-rata share contribution toward the Waiale Road Extension solely from the developer of Waikapu Country Town Project will not expedite the roadway's construction. Funding is a major component in bringing this roadway extension to fruition and we anticipate that other entities will need to commit to this improvement in order to move the roadway's construction forward. In addition to coordinating funding, the permitting phase for the roadway extension project may take some time to be completed as well.

2. Has the Department analyzed how current and future housing development projects in the area will collectively impact roadway infrastructure and traffic? If so, what are the results of your analysis?
