



Thour all men by these presents That I. William Charles Lunalits, of Honolula, Island of Jahr, one of the Hawaiian Islands, being of Round and disposing mind and memory, and well knowing the unan - die of home life, the heady make, put lish and declare this to be my Last Will and Victament in manner following, that is First; I give, devise and bequeath to my, Father Charles Kanaina, of Houstele, Island of Jahn aforesaid, all of the letate both but and personal, of which I may die verged and prosessed, wherever eiterated, the personal Estate absolutely, and To Hold and presess the real Estate aforesaid for and during the term of his natural life; and from and after his decease I give and devise the real Estate aforeraid, to my Cousin His Majesty Ramshamsha the Fifth, to be held and presend by him for and during the term of his natural by, in case he should be alive at any Father's decease. Second, In Case I should marry and have issue, then I do hereby give and devise all of my estate both, real and personal to my said child or children, their heis and assigns for ever, from and after the decease of my father Charles Kanaine,

Sather to have the new of my property during his life-time, in case he shall survive me.

From and after the decease of my devisees above named, to wit; Charles Kanaina ming Father, and His Majesty Kamshamsha the lifth and in case I shall die without jame lawfully begotten, I give and dense all of the real estate of which I may die seized and possessed, to three persons to be nominated and appointed by a majority of the fustices of the Supreme Court or the bout of the highest jurisdiction in these Nawaiian delands, to be held by them in trust, for the following purpose, to with; to sell and dispose of the said real Estate to the best advantage at public or private sale, and to invest the proceeds in Rome Reeme manner until the aggre gate sum shall amount to owenty five Thousand Dollars, or until the sum, realized by the said. Irastees shall, with donations or contributions from other sources amount to the said sum of Swenty fire Thomeand Sollars, then I order the Irustees ( to be appointed as aforesaid ) to expend the whole amount in the purchase of land and in the exetion of a building or buildings on the Island of lahu, of eron, stone, brick or

other fire proof material, for the use and accom odation of poor, destitute and infirm people of Marraian (aboriginal) blood or extraction, giving foreference to old people; whom such terms, rents or charges, as to the said majority of the justices of the Supreme Court, or Court of highest jurisdiction in these Hawaiian deland, shall seem peoper; and I hereby authorize any two of the said Instees (to be appointed as aforesaid , to act in all enables connected with this Trust, and I also authorize anajorily of the said Justices as aforesaid, to require accounts from the said Justes, to me now then from the said Smoot, and their places to fill, at pleasure: But, in case, sufficient buildings shall have been provided for the we and accomodation of poor, destitute and infirm Harraiians as aforesaid, then I hereby order and direct that the earl Trustees shall apply the net rents, issues and profils arising from the principal sum realized from the said real tate, when sold as afre it, to not main taining the said buildings in repair, in their improvement and towards the support and maintenance of the circulate aforesaid, as in the opinion of the said Inestees shall seem I' Fourth: It is my Will that my remains be

deposited in the same Somt with my Pather

Charles Kanaine, wherever he may be intombed or jutined, and I desire my Executor to see the foregoing provision carried out. Tifth; I hereby mornimate and appoint Charles A. Bishop of Honolula aforesaid, to be Executor of this my East Will and Sestament, hereby revoking all former Will by me at anytime made. In Witness whereof I have hereunts set my hand and seal this fune day of June a.D., Our Thousand Eight Hundred and Twenty one. Milliam C. Lunalile The above written instruments, consisting of our sheet was, on this 7th day of June ad, 1841, signed, realed, published and declared by the said William Charles dunalile, as and for his dast Will and Sestament, in the presence of us, who, at his request and in his presented and in the presence of thereunto. I have signed our names as witheress therewater. I have fluxed fluxed for the Blue

Mheuas, I Tunalilo, now King of the Harrican Islands, have made my Last Will and Testament in writing bearing date the Seventh day of June in the year of our Lord one thousand Eight hundred and Deventyone, Now therefore I do by this any writing which Last Will and Testament and to be taken as a part thereof, alter and amend the said Last Will and Vestament, as follows; Point; The articles of Rilow ware inherited by me from my Mostres, I hereby devise and bequeatto, after the decease of my father, to Second: After the decease of my father I devise the premises at Waikilli, Oahu, Kurun as any Marine Residence, to Ensew Emma, her heirs and accigns forsver. Third: I hereby direct that my Executor cause to be Evented in the Komaiahas Church. feet, a Henolulus, a sentable tomb in which I order that my remains be deposited, dearing also that upon the decease my father his remains be placed there. - my Will is that article third of my said Will be modified as follows; if the avails of the real Estate when pold, after the decease of my father, shall amount to more then Leventy five Thousand

Dollars, then and in that case, I direct my frustees an aforesaid who appoint ed, to invest the excess of the mails of the real Estate over and above the said sum of truly five thousand Dollars, and it apply the net cienes and werne arising herefrom homands mointaining the soid buildings, the creeted as in my Will directed, in repair, and in the support and mainthomas of the immates thereof, as in the specien of the Frestees aforesaid shall seem best. In Withing whereof I have, hereunto let any hand and real this Kirtyfort day Eight Hundred and Parenty four. Lunalilo 3 by A. F. Juice Signed by A. T.
