A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.44, MAUI COUNTY CODE, RELATING TO BOND COVERAGE FOR MEMBERS AND SUBORDINATES OF THE MAUI REDEVELOPMENT AGENCY

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 2.44, Maui County Code, is amended by adding a new section to be appropriately designated and to read as follows:

"2.44.040 Maui redevelopment agency bond coverage. The director of finance shall procure a bond for the members of the Maui redevelopment agency and, if required by the agency, its subordinates, to satisfy the requirements of section 53-2, Hawaii Revised Statutes."

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.
