The Maui Redevelopment Agency, also known as the MRA, reviews applications for new development and renovation projects in the Wailuku Redevelopment Area as authorized by Section 53-5 of the Hawai'i Revised Statutes pertaining to the Urban Renewal Law.

The Wailuku Redevelopment Area covers approximately 68 acres and includes the business blocks from Central Avenue to High Street, and Wells Street to Vineyard Street. The redevelopment area extends the length of Market Street from Wells through Happy Valley to where Kahekili Highway
