The Makila project near Launuipoko is the wrong location for this particular proposal because it's not about AH ...It's about exploitation and greed..Too many Market priced homes are included.

The 60 people who spoke out against it on the June 20th Hearing before the AH committee, both Hawaiian and Haole, were spot on.

This Project calls for 100 or 200 homes, most of them would be Market priced, multimillion dollar homes that would be bought by offshore investors.

Enough of that!

There is no infrastructure in that area.

There's a Severe water shortage, although the people involved with the developer say otherwise, but have no proof...

There is EXTREME fire vulnerability in that area already.

There is Traffic gridlock on the west side that's getting worse.

It's in Very close proximity to the shoreline, which should be environmentally unacceptable because homes would be approximately one half a mile from the ocean;

100 to 200 Market priced homes that only the wealthy could afford.

The constant offshore winds would blow dirt and dust from the construction directly into the ocean .. and this would go on for YEARS, surely destroying the already dying coral reefs .. Is that what we want???

Next to Truly affordable homes, our Ocean and the life it sustains should be everyone's MOST

IMPORTANT concern! And the coral reefs need our protection! Our ocean is why tourists come here!!!

There is an opportunity here now for the people in positions of power to set a POSITIVE example to the world by showing that Maui is an island that did it RIGHT....that listened to its people and planned a community with housing for its citizens as well as protected its ocean and land by stopping overdevelopment;

By being Conscientious about what is BEST for our fragile island and what is needed MOST for the average MAJORITY of the citizens who live and work here.
