**SUBJECT: APPROVING THE DIRECTOR OF FINANCE TO  
COMPROMISE A CLAIM RELATING TO REAL  
PROPERTY TAXES (EDB-16)**

The Economic Development and Budget Committee is in receipt of County Communication 19-140, transmitting a proposed resolution entitled "APPROVING THE DIRECTOR OF FINANCE TO COMPROMISE A CLAIM RELATING TO REAL PROPERTY TAXES FOR TMK NO. (2) 2-1-013-079."

Subsection 3.48.010(L), Maui County Code, requires Council approval if the compromised claim exceeds \$500. It also requires your Department to place on file a statement of:

1. The amount of tax assessed or proposed to be assessed;
2. The amount of penalties and interest imposed or proposed to be assessed;
3. The amount of penalties and interest imposed or which could have been imposed by law with respect to subdivision 1 of this subsection as computed by the director;
4. The total amount of liability as determined by the terms of the compromise, and the actual payments made thereon with the dates thereof; and

5. The reasons for the compromise.

May I please request a copy of the statement and the amount that the Department is requesting the claim be settled for. If the amount is confidential, and you will be requesting an executive meeting to discuss it, please advise.
