APPROVING THE DIRECTOR OF FINANCE TO COMPROMISE A CLAIM RELATING TO REAL PROPERTY TAXES FOR TAX MAP KEY (2) 2-1-013:079

WHEREAS, Subsection 3.48.010(L), Maui County Code, authorizes the Director of Finance, with the approval of the Corporation Counsel, to compromise any claim relating to real property tax; and

WHEREAS, the Corporation Counsel has approved this compromise proposed by the Director of Finance; and

WHEREAS, this compromise involves a claim exceeding five hundred dollars; and

WHEREAS, Subsection 3.48.010(L), Maui County Code, further requires that for the compromise of any claim exceeding five hundred dollars, the Director of Finance shall obtain the approval of the County Council; and

WHEREAS, Section 4-1 of the Revised Charter of the County of Maui (1983), as amended, provides that the Council may act by Resolution; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 2. That it hereby authorizes the Mayor and the Director of Finance to execute any documents furthering the intent of this Resolution; and
