Chair and Members:

Your Governance, Ethics, and Transparency Committee, having met on July 2, 2019, makes reference to County Communication 19-29, from Council Chair Kelly T. King, relating to litigation matters.

By correspondence dated June 13, 2019, the Department of the Corporation Counsel requested consideration of the possible settlement of Kelly Pauole v. County of Maui Police Department, et al., Civil 18-1-0007(2). Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF KELLY PAUOLE VS. COUNTY OF MAUI POLICE DEPARTMENT CIVIL NO. 18-1-0007(2)." The purpose of the proposed resolution is to authorize the Department to settle the case.

The Department also transmitted a copy of the First Amended Complaint. The First Amended Complaint alleges employment discrimination and retaliatory acts by the Department of Police against Plaintiff Kelly Pauole.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided a brief overview of the case. The Deputy said the case is set for trial in November 2019 and the parties are currently engaged in discovery. He also said the County has received a settlement demand from Mr. Pauole's attorney that he wished to present in an executive meeting.

Because the case involves ongoing litigation and confidential medical issues, the Deputy requested the opportunity to convene an executive meeting.

Your Committee voted to convene an executive meeting, closed to the public, to consult with legal counsel pursuant to Section 92-5(a)(4), Hawaii Revised Statutes; and Section 92-5(a)(8), Hawaii Revised Statutes, to deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a State or Federal law, or a court order.

Following the executive meeting, your Committee reconvened in regular session. Based on the information received and the recommendation of the Department, your Committee voted 6-1 to recommend adoption of the proposed resolution. Committee Chair Molina and members Hokama, Kama, Lee, Paltin, and Sinenci voted "aye." Committee Vice-Chair Rawlins-Fernandez voted "no." Committee members King and Sugimura were excused.

Your Committee revised the proposed resolution by removing the phrase "under such terms and conditions as may be imposed, and agreed to, by the Corporation Counsel" from the second and third BE IT RESOLVED paragraphs.

Your Committee is in receipt of a revised proposed resolution, entitled "AUTHORIZING SETTLEMENT OF KELLY PAUOLE VS. COUNTY OF MAUI POLICE DEPARTMENT, ET AL., CIVIL NO. 18-1-0007(2)," approved as to form and legality by the Department of the Corporation Counsel, incorporating your Committee's recommended revisions and nonsubstantive revisions.
