SUBJECT: FINES FOR UNPERMITTED OPERATION OF TRANSIENT ACCOMMODATIONS

Please find attached a proposed bill, titled "A BILL FOR AN ORDINANCE RELATING TO CIVIL FINES FOR UNPERMITTED TRANSIENT ACCOMMODATIONS." The bill's purpose is to establish an initial civil fine of up to \$20,000 and subsequent daily fines of up to \$10,000 for the operation of a Bed and Breakfast Home, Short-Term Rental Home, or Transient Vacation Rental without a necessary permit.

This Planning Director-initiated proposed bill is intended to implement the amendment to the Revised Charter of the County of Maui (1983), as amended, that was proposed by Resolution 18-125 and approved by the electorate at the 2018 General Election.

The bill is a proposal for a land use ordinance of general applicability. Accordingly, all three planning commissions were afforded an opportunity to review and comment on the bill prior to the Council's consideration, pursuant to Charter Section 8-8.4.

The Department of Planning transmitted a preliminary version of the bill to the Lanai, Maui, and Molokai Planning Commissions, consistent with Charter requirements. This preliminary version went beyond the scope of the Charter amendment and would also have imposed these higher fines for violations of permit conditions and other infractions. The three commissions uniformly opposed this broader scope, and strongly supported a scope that was consistent with the Charter. The planning commissions each conducted a duly noticed public hearing and deliberated on the proposed bill. The attached proposed bill incorporates the commissions' recommendations. Following is a summary.

Additional recommendations for Lanai include: certified mail for initial method of contact; prepare method to provide additional consideration for permitted operators who have made minor infractions or inadvertently allowed their permit to lapse; ensure the unpermitted operator has a sufficient opportunity to understand the potential financial hazard and rectify the situation before fines begin.

A BILL FOR AN ORDINANCE AMENDING SECTION 19.530.030, MAUI COUNTY CODE, RELATING TO CIVIL FINES FOR UNPERMITTED TRANSIENT ACCOMMODATIONS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. The purpose of this ordinance is to implement the 2018

Charter amendment relating to civil fines for unpermitted transient

accommodations.

SECTION 2. Section 19.530.030, Maui County Code, is amended by

amending subsection A and subsection B to read as follows:

"19.530.030 Administrative enforcement. In lieu of, or in addition to, enforcement by criminal prosecution, if the director of public works, the director of environmental management, the director of water supply, or the planning director determines that any [persons are] person is violating or has violated any provision of titles 8, 12, 14, 16, 18, 19, and 20 of this code, any rules adopted thereunder, or any permit issued thereto, the director with jurisdiction over the relevant ordinance, rule, or permit, may have the person served[,] by mail with proof of mailing or personal delivery, with a notice of violation and order pursuant to this chapter and such administrative rules as the director may adopt. Should service by mail or personal delivery fail, the director may serve notice by posting the notice of violation and order in a conspicuous place on the property where the violation is occurring or at the last known address of the violator, or by publishing a notice at least once per week for two consecutive weeks in a newspaper of general circulation in Maui County.

A. Contents of the notice of violation. The notice shall include at least the following information:

1. Date of the notice [;].

2. The name and address of the person noticed [;].

3. The section number of the provision or rule, or the number of the permit [which] <u>that</u> has been violated [;].

4. The nature of the violation [; and].

5. The location and [time] <u>date</u> of the violation.

B. Contents of the order.

1. The order may require the person to do any or all of the following:

a. Cease and desist from the violation [;].

b. Correct the violation at the person's own expense before a date specified in the order [;].

c. Pay a civil fine not to exceed \$1,000.00 in the manner, at the place, and before the date specified in the order [;], provided, however, that the initial civil fine shall not exceed \$20,000 for the operation of a bed and breakfast home, short-term rental home, or transient vacation rental without a necessary bed and breakfast home permit, short-term rental home permit, or conditional permit as required by the comprehensive zoning ordinance, unless a higher fine is authorized by State law [;].

d. Pay a civil fine not to exceed \$1,000.00 per day for each day in which the violation persists, in the manner and at the time and place specified in the order[; and], provided, however, that the daily civil fine shall not exceed \$10,000 for the operation of a bed and breakfast home, short-term rental home, or transient vacation rental without a necessary bed and breakfast home permit, short-term rental home permit, or conditional permit as required by the comprehensive zoning ordinance, unless a higher fine is authorized by State law[; and].

e. Pay a civil fine not to exceed one percent of the project cost as provided in [Section] <u>section</u> 20.08.260.E.2 of this code.

2. The order shall advise the person that the order shall become final thirty days after the date of its mailing or delivery. The order shall also advise that the director's action may be appealed to the board of variances and appeals."

SECTION 3. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring. SECTION 4. This ordinance shall take effect upon its approval.
