As such, we hereby notify you of the transfer of \$10,117.06 from Countywide Costs – Terminal Pay - Salary Adjustments (907774A) to the Department of Fire – Administration Program (911018A) in the amount of \$3,990.42 and the Department of the Prosecuting Attorney – Administration Program (906016A) in the amount of \$6,126.64.
