A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR
OF THE COUNTY OF MAUI TO ENTER INTO AN
INTERGOVERNMENTAL AGREEMENT WITH THE
DEPARTMENT OF THE ATTORNEY GENERAL, STATE OF HAWAII

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. <u>Purpose</u>. The Department of the Attorney General, State of Hawaii ("Agency"), through the Crime Prevention and Justice Assistance Division, will provide a maximum amount of \$54,962.00 to the Department of Police, County of Maui, through Contract Project Number 17-WF-06, as more fully described in Exhibit "1", attached hereto and incorporated herein. The Agency is the designated State Administering Agency for purposes of disbursing federal funds to develop and strengthen effective law enforcement and prosecutorial strategies and victim services in cases involving crimes against women.

This grant award requires that the County provide matching funds in the amount of \$18,321.00.

Section 2.20.020, Maui County Code, provides that, unless authorized by ordinance, the Mayor shall not enter into any intergovernmental agreement or any amendment thereto which places a financial obligation upon the county or any department or agency thereof.

SECTION 2. <u>Council authorization</u>. Pursuant to Section 2.20.020, Maui County Code, the Council of the County of Maui hereby authorizes the Mayor to

execute the Agreement, all other necessary documents relating to the Agreement, and any amendments thereto.

SECTION 3. Effective date. This ordinance shall take effect upon its approval. All action heretofore taken, not inconsistent with the provisions of this ordinance, is hereby ratified, approved and affirmed.

CONTRACT

THIS CONTRACT, executed on the respective dates indicated below, is effective as of <u>July 1, 2019</u>, by and between the Department of the Attorney General, State of Hawaii, hereinafter called "Agency," by and through the Attorney General, and the <u>Maui Police Department</u>, whose business address is <u>County of Maui</u>, a political subdivision of the State of <u>Hawaii</u>, whose business address is 55 Mahalani Street, Wailuku, <u>Hawaii 96793</u>, hereinafter called "Grantee," for the benefit of the Maui Police Department, which is identified as the applicant on Exhibit "A" attached hereto.

WITNESSETH

WHEREAS, Title IV of the Violent Crime Control and Law Enforcement Act of 1994, 42 U. S. C. 3796 et seq., as amended (hereinafter "Act"), was enacted to make grants to states for developing and strengthening effective law enforcement and prosecutorial strategies and victim services in cases involving crimes against women. Offices and agencies of the state

government, units of local government, Indian tribes, and nonprofit, non-governmental victim services programs are eligible to apply to states for subgrants under the twenty broad purpose areas:

- (1) training law enforcement officers, judges, other court personnel, and prosecutors to more effectively identify and respond to violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking, including the appropriate use of nonimmigrant status under subparagraphs (T) and (U) of section 1101(a)(15) of the Immigration and Nationality Act (8 U.S.C. 1101(a));
- (2) developing, training, or expanding units of law enforcement officers, judges, other court personnel, and prosecutors specifically targeting violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking;
- (3) developing and implementing more effective police, court, and prosecution policies, protocols, orders, and services specifically devoted to preventing, identifying, and responding to violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking, as well as the appropriate treatment of victims;

- (4) developing, installing, or expanding data collection and communication systems, including computerized systems, linking police, prosecutors, and courts or for the purpose of identifying, classifying, and tracking arrests, protection orders, violations of protection orders, prosecutions, and convictions for violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking;
- (5) developing, enlarging, or strengthening victim services and legal assistance programs, including sexual assault, domestic violence, stalking, and dating violence programs, developing or improving delivery of victim services to underserved populations, providing specialized domestic violence court advocates in courts where a significant number of protection orders are granted, and increasing reporting and reducing attrition rates for cases involving violent crimes against women, including crimes of domestic violence, dating violence, sexual assault, and stalking;
- (6) developing, enlarging, or strengthening programs addressing the needs and circumstances of Indian tribes in dealing with violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking;

- (7) supporting formal and informal statewide, multidisciplinary efforts, to the extent not supported by state funds, to coordinate the response of state law enforcement agencies, prosecutors, courts, victim services agencies, and other state agencies and departments, to violent crimes against women, including the crimes of sexual assault, domestic violence, dating violence, and stalking;
- (8) training of sexual assault forensic medical personnel examiners in the collection and preservation of evidence, analysis, prevention, and providing expert testimony and treatment of trauma related to sexual assault;
- (9) developing, enlarging, or strengthening programs to assist law enforcement, prosecutors, courts, and others to address the needs and circumstances of older and disabled women who are victims of domestic violence, dating violence, sexual assault, or stalking, including recognizing, investigating, and prosecuting instances of such violence or assault and targeting outreach and support, counseling, and other victim services to such older and disabled individuals;
- (10) providing assistance to victims of domestic violence and sexual assault in immigration matters;
- (11) maintaining core victim services and criminal justice initiatives, while supporting complementary new initiatives and emergency services for victims and their families;

- (12) supporting the placement of special victim assistants (to be known as "Jessica Gonzales Victim Assistants") in local law enforcement agencies to serve as liaisons between victims of domestic violence, dating violence, sexual assault, and stalking and personnel in local law enforcement agencies in order to improve the enforcement of protection orders. Jessica Gonzales Victim Assistants shall have expertise in domestic violence, dating violence, sexual assault, or stalking and may undertake the following activities
 - o developing, in collaboration with prosecutors, courts, and victim service providers, standardized response policies for local law enforcement agencies, including the use of evidence-based indicators to assess the risk of domestic and dating violence homicide and prioritize dangerous or potentially lethal cases;
 - o notifying persons seeking enforcement of protection orders as to what responses will be provided by the relevant law enforcement agency;
 - o referring persons seeking enforcement of protection orders to supplementary services (such as emergency shelter programs, hotlines, or legal assistance services); and

- o taking other appropriate action to assist or secure the safety of the person seeking enforcement of a protection order; and
- (13) providing funding to law enforcement agencies, victim service providers, and state, tribal, territorial, and local governments (which funding stream shall be known as the Crystal Judson Domestic Violence Protocol Program) to promote:
 - o the development and implementation of training for local victim domestic violence service providers, and to fund victim services personnel, to be known as "Crystal Judson Victim Advocates," to provide supportive services and advocacy for victims of domestic violence committed by law enforcement personnel;
 - o the implementation of protocols within law enforcement agencies to ensure consistent and effective responses to the commission of domestic violence by personnel within such agencies such as the model policy promulgated by the International Association of Chiefs of Police ("Domestic Violence by Police Officers: A Policy of the IACP, Police Response to Violence Against Women Project" July 2003); and

o the development of such protocols in collaboration with state, tribal, territorial and local victim service providers and domestic violence coalitions;

Any law enforcement, state, tribal, territorial, or local government agency receiving funding under the Crystal Judson Domestic Violence Protocol Program shall, on an annual basis, receive additional training on the topic of incidents of domestic violence committed by law enforcement personnel from domestic violence and sexual assault nonprofit organizations and, after a period of two years, provide a report of the adopted protocol to the Department of Justice, including a summary of progress in implementing such protocol; and

- (14) developing and promoting state, local, or tribal legislation and policies that enhance best practices for responding to domestic violence, dating violence, sexual assault, and stalking;
- (15) developing, implementing, or enhancing Sexual Assault

 Response Teams, or other similar coordinated community
 responses to sexual assault.
- (16) developing and strengthening policies, protocols, best practices, and training for law enforcement agencies and prosecutors relating to the investigation and prosecution

- of sexual assault cases and the appropriate treatment of victims;
- (17) developing, enlarging or strengthening programs addressing sexual assault against men, women, and youth in correctional and detention settings;
- (18) identifying and conducting inventories of backlogs of sexual assault evidence collection kits and developing protocols and policies for responding to and addressing such backlogs, including protocols and policies for notifying and involving victims;
- (19) developing, enlarging, or strengthening programs and projects to provide services and responses to male and female victims of domestic violence, dating violence, sexual assault, or stalking, whose ability to access traditional services and responses is affected by their sexual orientation or gender identity, as defined in section 249(c) of title 18, United States Code; and
- (20) developing, enhancing, or strengthening prevention and educational programming to address domestic violence, dating violence, sexual assault, or stalking, with not more than 5 percent of the amount allocated to a state to be used for this purpose.

WHEREAS, the Governor has designated Agency to serve as Hawaii's office for administering the federal financial assistance available under the Act;

WHEREAS, Grantee is qualified to receive Hawaii under the Act and its respective available to implementing regulations contained in the STOP Violence Against Program Guidance, and the Formula Grant Women Principles, Administrative Requirements, Cost and Requirements in 2 C.F.R. Part 200, as adopted and supplemented by the Department of Justice in 2 C.F.R. Part 2800 (together, the "Part 200 Uniform Requirements") and has applied to Agency for receipt of the same as a subgrantee;

WHEREAS, Agency has reviewed Grantee's application for funds, and is satisfied that all of the requirements of the Act and its implementing regulations have been satisfied and that Grantee is capable of using the requested federal funds appropriately;

WHEREAS, Grantee has demonstrated the capacity to provide the services, programs and activities described herein and is ready, willing and able to provide the required services, programs and activities;

NOW THEREFORE, Agency and Grantee for and in consideration of the covenants, conditions, agreements, and stipulations hereinafter expressed, do mutually agree as follows:

A. SCOPE OF SERVICES.

Grantee shall, in a proper and satisfactory manner, as determined by Agency, and in accordance with the terms and conditions of this Contract, use the funds received under this Contract for the purposes stated herein and in accordance with the "Application For Grant" (Parts I through IV including all certifications required under Section C) and the Acceptance of VAWA Special Conditions attached hereto as Exhibit "A" and by reference incorporated herein. It is understood that this Contract includes as a part hereof any rules, relevant directives or instructions issued by the United States or the Agency, including the provisions of the federal Office of Management and Budget's Uniform Guidance and the effective edition of the Department of Justice Programs' financial manual entitled "DOJ Grants Financial Guide."

B. TERM OF CONTRACT.

This Contract shall be in effect for the period from <u>July 1, 2019</u> to and including <u>June 30, 2020</u> unless this Contract is sooner terminated as hereinafter provided or unless this Contract is extended in accordance with Section L of this Contract.

C. PERFORMANCE REQUIREMENTS AND CONDITIONS.

- 1. Grantee shall comply with the guidelines set forth in the Act and all applicable federal regulations and guidelines, including but not limited to guidance issued by the Office on Violence Against Women, Part 200 Uniform Requirements, and the effective edition of the "DOJ Grants Financial Guide."
- 2. Grantee shall comply with all the ordinances, codes, rules and regulations of the Federal, State and local government which in any way affect its performance under this Contract.
- 3. Grantee shall provide for an independent audit of its activities on a periodic basis in accordance with Part 200 Uniform Requirements.
- 4. Prior to, or concurrently with the execution of this Contract, if so required by Agency, Grantee shall complete, execute and submit to Agency a Certification Regarding Drug-Free Workplace Requirements which meets the requirements of

the Drug-Free Workplace Act of 1988 (Pub. L. 100-690, Title V, Subtitle D, U.S.C., Title 41, Chapter 10, §702), hereinafter referred to as the "Drug-Free Workplace Certification." A copy of the Drug-Free Workplace Certification shall be included in Part IV of the Application for Grant. Grantee covenants that the representations made in the Drug-Free Workplace Certification are true at the time this Contract is executed and will remain true throughout the entire term of this Contract and any extensions, and that Grantee shall fulfill all requirements set forth therein. Grantee's execution submission of a false Drug-Free Workplace Certification, or Grantee's violation of any or all of the requirements set forth therein shall entitle Agency to suspend one or more payments under this Contract, and/or terminate this Contract pursuant to the provisions of Section N of this Contract. Grantee warrants that it is aware that such false certification or violation of the requirements contained in the Drug-Free Workplace Certification shall subject the State of Hawaii to governmentwide suspension or debarment, or other sanctions which, in turn, shall result in the withdrawal of funds from Grantee and/or the unavailability of future funding for Grantee.

5. Prior to, or concurrently with the execution of this Contract, Grantee shall complete, execute and submit to Agency a Certification Regarding Debarment, Suspension,

Ineligibility and Voluntary Exclusion, hereinafter referred to as the "Debarment Certification." A copy of the Debarment Certification shall be included in Part IV of the Application for Grant. Grantee covenants that the representations made in the Debarment Certification are true at the time this Contract is executed and will remain true throughout the entire term of the Contract and any extensions, and that Grantee shall fulfill any and all terms and conditions set forth therein.

- 6. Prior to, or concurrently with the execution of this Contract, Grantee shall complete, execute and submit to Agency a Certification of Non-Supplanting, hereinafter referred to as the "Non-Supplanting Certification." A copy of the Non-Supplanting Certification shall be included in Part IV of the for Grant. Grantee covenants that Application the representations made in the Non-Supplanting Certification are true at the time this Contract is executed and will remain true throughout the entire term of the Contract and any extensions, and that Grantee shall fulfill any and all terms and conditions set forth therein.
- 7. Prior to, or concurrently with the execution of this Contract, if so required by Agency, Grantee shall complete, execute and submit to Agency a Certification Regarding Lobbying, hereinafter referred to as the "Lobbying Certification," and any subsequent disclosure forms required

under Section 1352, Title 31 U. S. C. A copy of the Lobbying Certification shall be included in Part IV of the Application for Grant. Grantee covenants that the representations made in the Lobbying Certification are true at the time this Contract is executed and will remain true throughout the entire term of the Contract and any extensions, and that Grantee shall fulfill any and all terms and conditions set forth therein.

8. Grantee shall comply with the nondiscrimination requirements of the Omnibus Crime Control and Safe Streets Act of 1968 which prohibits discrimination in employment and in the delivery of services or benefits on the basis of race, color, national origin, religion, or sex; Title VI the Civil Rights Act οf 1964 which prohibits discrimination in the delivery of services or benefits on the basis of race, color, or national origin; Section 504 of the Rehabilitation Act of 1973 and Title II of the Americans with Disabilities Act of 1990 which prohibit discrimination employment and in the delivery of services or benefits based on disability; Title IX of the Education Amendments of 1972 which prohibits discrimination on the basis of sex in training or educational programs; the Age Discrimination Act of 1975 which prohibits discrimination in the delivery of services or benefits on the basis of age; the Department of Justice regulations implementing the above-referenced statutes at 28 C.F.R. Part 42,

subpts. C, D, G, and I, 28 C.F.R. Part 35, and 28 C.F.R. Part 54; Exec. Order No. 13279, 28 C.F.R. Part 38 (equal protection of the laws for faith-based and other neighborhood community organizations); Exec. Order No. 13166 and U.S. Department of Justice, Guidance to Federal Financial Assistance Recipients National VI Prohibition Against Origin Regarding Title Discrimination Affecting Limited English Proficient Persons; the Hawaii State Fair Employment Practices Act, Chapter 378, Hawaii Revised Statutes; and all other applicable federal and state laws, rules and regulations.

- 9. Grantee assures Agency that if it is required to formulate an Equal Employment Opportunity Program in accordance with 28 C.F.R. §§ 42.301 et seq. it will submit a certification to Agency that a current program is on file.
- and practices acceptable to Agency, and books, records, documents and other evidence which sufficiently, accurately and properly reflect all direct and indirect expenditures and all interest or other income earned as the result of funds provided pursuant to this Contract. Grantee shall ensure that its own books, records, and documents are available for inspection, reviews or audits at all reasonable times by Agency or the United States Department of Justice. In addition, Grantee shall prepare and submit to the Agency reports in such form and at

such times as Agency or the Office on Violence Against Women may require. Grantee shall submit quarterly financial reports fifteen (15) calendar days after the end of each calendar quarter. Grantee shall submit monthly request for funds and cash balance reports fifteen (15) calendar days after the end of each month. The final fiscal reports must be received by Agency within sixty (60) days after the date this Contract terminates or unless mandated earlier by Agency. Records and financial accounts shall be retained by the Grantee and shall be accessible to Agency and the United States Department of Justice for at least three years after Agency's grant with the Office on Violence Against Women is closed.

- 11. The final drawdown for funds must be received by Agency within thirty (30) days after the date this Contract terminates.
- 12. Any funds provided to Grantee under this Contract which are unencumbered on the date this Contract terminates shall be returned to Agency; all funds provided under this Contract which are encumbered but not disbursed within sixty (60) days after this Contract terminates shall be returned to Agency.
- 13. Grantee shall submit progress reports as required for the Act funds to Agency as stipulated under Part

- IV. of the Application for Grant, Attachments, Acceptance of VAWA Special Conditions.
- 14. If so required by Agency, Grantee shall certify to Agency that any expendable or nonexpendable personal property purchased or acquired with funds received under this Contract will be used for criminal justice purposes before title in such property may vest in Grantee. Grantee shall submit a certification to Agency within thirty (30) days after the date this Contract terminates. If a certification is not provided by Grantee, title to any personal property purchased or acquired with funds received under this Contract shall vest in Agency and such personal property shall be delivered to the Agency in good working order upon expiration or sooner termination of this Contract.
- three hundred twenty-one and 00/100 dollars (\$18,321.00) are available as matching funds to provide the services under this Contract. Grantee shall maintain records which clearly and accurately show the source, amount and the timing of match contributions. If, at the end of the Contract period, Agency determines that Grantee does not have the required matching contribution, Grantee shall return all of the federal portion of the project cost for which Grantee does not have the required match.

D. PERSONNEL.

- 1. Grantee shall secure at its own expense all personnel required to perform the services required under this Contract. All such personnel shall not be considered employees of, or have any contractual relationship with the State of Hawaii unless Grantee is otherwise an agency of the State.
- 2. Grantee shall ensure that none of the work or services to be provided under this Contract shall be subcontracted or assigned without the prior written approval of Agency.

E. <u>SUBCONTRACTS</u>.

Grantee may provide some or all of the services required under this Contract by subcontract provided that Grantee secures the prior written consent of Agency. In the event Grantee enters into a subcontract with a private organization to perform any of the services or activities required under this Contract, Grantee agrees that the period of each subcontract shall not exceed the term of this Contract, and funds to the private organization will not be released unless and until the requirements set forth in applicable state law and implementing rules are complied with by the subcontractor. All subcontracts shall include provisions to ensure that Grantee is

capable of satisfying the requirements of this Contract. All subcontracts shall be reduced to writing and shall include all provisions of this Contract required of Grantee.

F. SERVICES AS INDEPENDENT CONTRACTOR.

In the performance of the services required 1. under this Contract, Grantee shall be an independent contractor with the authority to control and direct the performance and details of the work and services required under this Contract; however, Agency shall have the right to inspect work in progress to determine whether, in Agency's opinion, the work is being performed by Grantee in accordance with the provisions of this All persons hired or used by Grantee shall be Contract. Grantee's agents and employees and Grantee shall be responsible for the accuracy, completeness, and adequacy of any and all work performed by its agents and employees. and services Furthermore, Grantee intentionally, voluntarily, and knowingly assumes the sole and entire liability if such liability is determined to exist, to its agents and employees or to third loss, cost, damage or injury caused by persons, for all Grantee's agents and employees in the course of employment. The performance of work under this Contract alone shall not be construed as employment with the State of Hawaii not entitle Grantee's agents shall and employees to and

vacation, sick leave, retirement, or other benefits directly afforded state employees by statutes. Grantee shall be responsible for payment of all applicable federal, state, and county fees which may become due and owing by the Grantee by reason of the Contract, including but not limited to (i) income taxes, (ii) employment related fees, assessments and taxes and (iii) general excise taxes. The Grantee also is responsible for obtaining all licenses, permits and certificates that may be required in order to perform this Contract.

2. This section shall not be applicable if Grantee is an agency of the State of Hawaii.

G. COMPENSATION.

1. Subject to continuing availability of funds, Agency agrees to pay Grantee, for services satisfactorily performed under this Contract, a sum not to exceed fifty-four thousand nine hundred sixty-two and 00/100 dollars (\$54,962.00) to be spent for the purposes of this Contract. This sum represents any and all compensation to be paid to Grantee for any and all services it provides, and for any and all travel costs, materials, supplies, equipment, overhead, taxes, and other incidentals and operating expenses which it incurs or may incur in connection with this Contract.

2. It is covenanted and agreed by and between the parties hereto that, as to the portion of the obligation under this Contract to be payable out of federal funds, this Contract shall be construed to be an agreement to pay such portion to the Grantee only out of federal funds to be received from the federal government when the federal funds are so received and shall not be construed as a general agreement to pay such portion at all events out of any funds other than those which are received from the federal government.

H. METHOD OF PAYMENT.

- All funds available for use under this Contract shall be subject to the allotment system as provided in Chapter 37, Hawaii Revised Statutes.
- 2. Payments to Grantee under this Contract shall be made in accordance with and subject to the following provisions:
- a. Payments shall be made monthly upon receipt of Grantee's completed request for funds.
- b. All payments shall be made in accordance with and subject to Chapter 40, Hawaii Revised Statutes, which specifies the accounting procedures and controls applicable to payments out of the Treasury of the State of Hawaii.

c. If an amount of reported expenditures is preliminarily determined by Agency to be inappropriate and unallowable, Agency may deduct an equivalent amount from the next payable installment and may withhold payment of the amount of the moneys equivalent to the questioned expenditures until later resolution of the discrepancy by audit or other means. If, after payment of the last installment, investigation and examination reveal additional expenditures that are determined by Agency to be inappropriate and unallowable, Agency may require that an equivalent amount of moneys be refunded to Agency notwithstanding Agency's preliminary determination of appropriateness and allowability.

d. Failure to submit required reports by the applicable deadline will result in the withholding of payments until such time as the reports are received by Agency. Grantee shall continue to provide the services, programs and activities during the period that payments are being withheld.

I. INDEMNIFICATION.

1. It is strictly understood that the State of Hawaii shall in no way be held liable for any damages, cause of action or suits resulting from the acts, activities or omissions of Grantee. Grantee shall indemnify and save harmless the State of Hawaii, Agency, and their officers, agents, and employees

from and against any and all liability, loss, actions, claims, suits, damages, costs or expenses, including all attorneys' fees, and all claims, suits, and demands therefor, arising out of or resulting from the acts or omissions of Grantee, its officers, employees, agents, or subcontractors occurring during or in connection with the performance of Grantee's services under this Contract, or arising out of or resulting from breach of this Contract by Grantee. Grantee shall defend the State of Hawaii, Agency, and their officers, agents, and employees against any such action or claim unless the action or claim involves an act or omission solely of Agency, its officers, agents, or employees.

- 2. This section shall not be applicable if Grantee is an agency of the State of Hawaii.
- 3. The County of <u>Maui</u> will indemnify the State of Hawaii, Agency, and their officers, agents, and employees to the extent permitted by law, and it is understood that payment is subject to approval by the county council/or city council, as the case may be.

J. CONFIDENTIAL MATERIAL.

Any information, data, report, record, summary, table, map, or study given to or prepared or assembled by Grantee under this Contract which is identified as proprietary

or confidential information that Agency requests to be kept confidential shall be safeguarded by the Grantee and shall not be made available to any individual or organization other than any subcontractor to which the material may relate, without prior written approval of Agency. Grantee shall submit a completed Privacy Certification for review and approval prior to the expenditure of funds for the collection of identifiable research/statistical data. All information, data, or other material provided by the Grantee or the Agency shall be kept confidential only to the extent permitted by law. Grantee shall comply with the requirements of Chapters 487J, 487N and 487R, Hawaii Revised Statutes as applicable.

K. COPYRIGHT AND PATENT.

The Agency shall have complete ownership of all material, both finished and unfinished, which is developed, prepared, assembled, or conceived by the Grantee pursuant to this Contract, and all such material shall be considered "works made for hire." No summary, report, map, chart, graph, table, study or other documents or discovery, invention, or development produced in whole or in part with funds made available under this Contract (collectively and individually "material") shall be the subject of an application for copyright or patent by or on behalf of Grantee, its officers, agents, or its employees, or

its subcontractors without prior written authorization from Agency. To the extent that any material, summary, report, map, chart, graph, table, study, or other documents, or discovery, invention, or development under this Contract is not recognized as a "work made for hire" as a matter of law, Grantee hereby assigns to the Agency any and all copyrights in and to the material.

L. MODIFICATION OF CONTRACT.

Any modification, alteration, amendment, or change to this Contract other than to the "Application For Grant" (attached hereto as part of Exhibit "A") or to the period during which this Contract is in effect in Section B, including increases (subject to the availability of funds) or decreases in the amount of compensation, permitted by this Contract shall be made by written supplemental agreement to this Contract and executed by Grantee and the Attorney General or the Attorney General's designee. Modifications, alterations or changes to provisions of the "Application For Grant" may be requested by Grantee, approved by the Administrator of the Crime Prevention and Justice Assistance Division on Agency's behalf, and made by substituting or inserting the revisions in Exhibit "A." Modifications, alterations or changes to the period during which this Contract is in effect may be requested in writing by

Grantee or Agency, up to forty-five (45) days before the Contract would otherwise terminate, and shall be effective as of the date approved by the Administrator of the Crime Prevention and Justice Assistance Division (if requested by Grantee) or Grantee (if requested by Agency) and made by attaching a party's written request with the other party's written approval thereon to this Contract. No oral modification, alteration, amendment, change, or extension of any term, provision or condition of this Contract shall be permitted.

M. CONFLICT OF INTEREST.

Grantee represents that it presently has no interest and promises that it shall not acquire any interest, direct or indirect, that would conflict in any manner or degree with the performance of the services under this Contract.

N. TERMINATION OF CONTRACT.

1. If, for any cause, Grantee refuses or fails to satisfactorily fulfill in a timely or proper manner its obligations under this Contract or any extension thereof, or if Grantee breaches any of the promises, terms or conditions of this Contract and, having been given reasonable notice of and opportunity to cure any such default, fails to take satisfactory corrective action within the time specified by Agency, Agency

shall have the right to terminate this Contract by giving written notice to Grantee of such termination ten (10) calendar days before the effective date of such termination. The Grantee shall continue performance of the Contract to the extent it is not terminated. Notwithstanding termination of the Contract, and subject to any directions from the Agency, the Grantee shall take timely, reasonable, and necessary action to protect and preserve property in the possession of the Grantee in which the Agency has an interest.

- 2. Furthermore, Agency may terminate this Contract without statement of cause at any time by giving written notice to Grantee of such termination at least thirty (30) calendar days before the effective date of such termination.
- 3. In the event of termination of either type, all finished or unfinished documents, reports, summaries, lists, charts, graphs, maps, or other written material prepared by Grantee, under this Contract shall, at the option of Agency, become Agency's property and, together with all information, data, reports, records, maps, and other materials (if any) provided to Grantee by Agency, shall be delivered and surrendered to Agency on or before the effective date of termination.

Any dispute concerning a matter of fact arising under this Contract or any subcontract, which is not disposed of by mutual agreement within fifteen (15) calendar days, shall be decided by the Attorney General, or the Attorney General's duly designated representative, who shall reduce the decision to writing and mail or otherwise furnish a copy of the decision to The decision of such person shall be final and Grantee. Pending final decision of such dispute, Grantee shall proceed diligently with the performance of this Contract in accordance with Agency's request. The validity of this Contract and any of its terms or provisions, as well as the rights and duties of the parties to this Contract, shall be governed by the laws of the State of Hawaii. Except as otherwise provided in this Section, any action to enforce this contract or for breach of this Contract shall be brought only in a State court of competent jurisdiction in Honolulu, Hawaii.

PART II. DESCRIPTION OF PROJECT

A. THE PROBLEM

Strangulation is one of the most lethal forms of intimate partner domestic violence with unconsciousness may occur within seconds and death within minutes. Victims may have no visible injuries or understand the seriousness of being strangled thus not reporting the incident or seeking medical attention. Strangulation is a form or power and control and the potential to a fatal outcome.

The proposed trainings will provide law enforcement personnel, medical personnel, advocate personnel and Prosecutors the ability to improve skills in investigation, report writing, observations of the victim, providing proper medical services and assistance, and prosecution of the defendant.

The following are the statistics for domestic violence incidents, specifically strangulation cases that were investigated by the Maui Police Department (MPD) and sent to the Maui Department of the Prosecuting Attorney:

<u>Year</u>	DV Cases	Strangulation Cases
2018	4,032	64
2017	3,823	72
2016	4,459	67
2015	4,376	76

The problem is evident that in Maui County, strangulation cases are on the rise and victims are coming forward to report the incident. Not all cases are being prosecuted due to lack of evidence or no cooperation from the victim to confirm initial statement to responding officer.

For law enforcement, medical personnel and services providers who come into contact with a victim of strangulation, there is often a lack proper awareness and knowledge of non-visible physical injuries and the effects they could have if not treated. The victim themselves may be unaware of the severity of their injuries and minimize the situation and refuse medical treatment. Following any type of domestic violence report, it is critical for the victims to get medical services, counseling, resource assistance, and documentation that will lead to successful prosecution of the perpetrator.

Per the Training Institute on Strangulation Prevention's Strangulation in Intimate Partner Violence Fact Sheet:

- Strangulation is defined as the obstruction of blood vessels and /or airflow in the neck resulting in asphyxia.
- One in four women will experience intimate partner violence (IPV) in their lifetimes, and of women at high risk, up to 68 percent will experience near-fatal strangulation by their partner.

• Loss of consciousness due to strangulation can occur withit 5 to 10 minutes, death within minutes.

Maui County had 12 domestic violence homicides between 2012 to 2016. These types of cases are investigated by a Crimes Against Persons Detective who has attended specialized trainings relating to homicides.

The MPD Domestic Violence Unit (DVU) is not called upon during these types of investigations due to the lack of specialized training relating to domestic violence homicides. VAWA funds have allowed domestic violence investigators to receive specialized trainings in domestic violence related issues.

Responding patrol officers are first on scene and will come face to face with those involved with a domestic type homicide from the victim, the offender, the children, family members and bystanders. Having to obtain pertinent information during their investigation while emotions are high will be important during the prosecution of the offender.

Providing first responders with up to date training in dealing with domestic violence homicides will ensure scene safety, evidence collection and report documentation for prosecution for these crimes.

Per the National Coalition Against Domestic Violence website:

- 1 in 3 female murder victims and 1 in 20 male murder victims are killed by intimate partners
- A study of intimate partner homicides found that 20% of victims were family members or friends of the abused partner, neighbors, persons who intervened, law enforcement responders, or bystanders
- 72% of all murder-suicides are perpetrated by intimate partners
- 94% of murder-suicide victims are female

Understanding the basic differences in the types of crimes against persons, the training for specific domestic violence strangulation and domestic violence homicides will be beneficial to the first responding patrol officers, patrol supervisors, Crimes Against Persons Detectives and Domestic Violence Unit to understand the concepts of violent crimes against women that may lead to homicide.

DVU currently conducts (24) hours of Domestic Violence Training and scenarios during recruit school instruction. DVU personnel will continue to present in-service trainings in addition to Annual Recall with information gathered from Prosecutors regrading new or amended domestic violence laws.

The Prosecutors will call upon the DVU Investigators to conduct immediate follow-up to cases to re-contact the victim, obtain additional statements of those involved, gather valuable evidence and information that may be required to charge a felony offense or upgrade a misdemeanor offense to a felony. Often times follow-ups done several days later may result in the victim becoming uncooperative or evidence being destroyed.

As domestic violence crimes increase law enforcement, medical personnel, advocate/counselor personnel and prosecutors collectively agree that continuous formal training for domestic violence

strangulation and homicide trainings will be beneficial for the entire process when dealing with such crimes of violence.

B. GOALS AND OBJECTIVES

Goal: To improve and sustain MPD's response to domestic violence strangulation and homicide cases throughout Maui County.

Objective #1: 85% of participants who attend community engagement forums in Lana'i, Moloka'i, and Hana will increase their understanding of strangulation and awareness of services available to rural victims.

Objective #2: 85% of DVU and other MPD personnel who participate in a specialized training will increase their understanding of domestic violence strangulation and homicide, and their ability to complete detailed reports for strangulation investigations that will lead to successful prosecutions.

Objective #3: 85% of DVU and other MPD personnel who attend national trainings on gender-based violence will increase their understanding of domestic violence and sexual assault victims, and will utilize best practices for investigating these types of cases.

Objective #4: 85% of DVU and other MPD personnel who attend "Their Voice" multidisciplinary training for law enforcement will increase their understanding of domestic violence and sexual assault victim experiences, and will utilize best practices for investigating these types of cases

Objective #5: 60% of domestic violence strangulation cases sent by DVU to Prosecutors will contain appropriate supporting evidence, which may include photos of victim's injuries, scene photos, and other collection of evidence that may lead to successful prosecution.

C. **PROJECT ACTIVITIES**

Activities that will support Objective #1:

- 1. DVU will coordinate with partner agencies to conduct a joint domestic violence strangulation forum in the communities of Lana'i, Moloka'i and Hana.
- 2. DVU and Crimes Against Persons Detectives who investigate sexaul assault crimes will work with government and partner agencies to be proactive with trainings, presentations and events for the community. Funding for overtime may be necessary if a meeting/investigation occurs after normal business hours.

Activities that will support Objective #2:

1. DVU will organize a two-day *DV Strangulation and Homicide* training for law enforcement, Prosecutors, emergency medical personnel, victim/witness counselors and domestic violence advocates on Maui. There will be up to 60 attendees to include personnel from outer islands.

- 2. Day 1 of the training will feature a presentation by Alliance for HOPE, Strangulation Training Institute. In 2015, the President's Family Justice Center Initiative changed its name to Alliance for HOPE. Day 2 of the training will feature a presentation by FBI Agents (pending confirmation). No fees will be expended for the FBI Agents' presentation.
- 3. The training will focus on first reponders for both law enforcement and medical personnel responding to such types of abuse cases. The training will be evidence-based to increase chances for a successful prosecution.
- 4. The training will cover case studies relating to homicide due to domestic violence and intimate partner strangulation. The presenters will review case studies that may have been lacking proper evidence, statements and cooperation and may have resulted in unsuccessful prosecution.

Activities that will support Objective #3:

- 1. MPD will send (2) MPD personnel to participate in the Voices in Action: 18th National Conference on Domestic Violence (NCADV) in Washington, D.C. from September 16-18, 2019.
- 2. MPD will send (4) MPD personnel to participate in the Family and Domestic Violence training by the Public Agency Training Council in Las Vegas, NV from December 2-3, 2019.
- 3. MPD will send (5) MPD personnel (to include, DVU personnel, Crimes Against Persons Detective, patrol officers or patrol sergeants) and (2) Domestic Violence Advocates to participate in the End Violence Against Women International (EVAWI) International Conference on Sexual Assault, Domestic Violence, and Violence Across the Lifespan in Washington, D.C. from April 14-16, 2020.
- 4. MPD will send (3) MPD personnel and (2) Domestic Violence Advocates to participate in the Crimes Against Women Conference (CAWC) in Dallas, TX from May 18-21, 2020.
- 5. MPD will send DVU personnel, Crimes Against Persons Detectives, and patrol officers/sergeants to a specialized training relating to domestic violence strangulation and homicide that will be organized by DVU.

Activities that will support Objective #4:

DVU will host a one-day conference for MPD personnel titled *Their Voice*, that will be co-hosted by Parents and Children Together (PACT) in August 2019. The one-day conference will feature a panel of survivors, all representing immigrant and indigenous cultures. The one-day conference will increase MPD personnel's understanding of the personal experiences of survivors of domestic violence and sexual assault.

Activities that will support Objective # 5:

1. DVU and the Department of the Prosecuting Attorney will continue to provide in-service training to MPD personnel with evidence collection (photos of victim/scene), medical documentation, and statements.

2. MPD will send DVU personnel, Crimes Against Persons Detectives, and patrol officers/sergeants to a specialized training relating to domestic violence strangulation and homicide that will be organized by DVU.

D. PROJECT ORGANIZATION AND MANAGEMENT

The Project Director is Detective/Sergeant Edith Quintero who is directly under the command of Lieutenant Derrick Lopez of MPD's Criminal Investigation Division.

The Project Director shall be responsible for the following:

- 1. Managing and coordinating project activities and ensuring that stated goals and objectives are met.
- 2. Managing funding and ensuring that funds will be encumbered within the project period.
- 3. Preparing semi-annual progress reports and a final report as required.
- 4. Submitting written requests for prior approval to the Department of the Attorney General for grant modification (if applicable), travel, and training.

Melissa Magonigle is the Business Administrator as of July 10, 2017. The Project Director will forward all budget reports to MPD's Accountant, Lesley Uemae who will prepare/submit all financial reports relating to the project.

E. PERSONNEL

The DVU is comprised of one Detective/Sergeant (supervisor) and two investigators. The DVU is a part of the Crimes Against Persons Unit, which is under the supervision of Lieutenant Derrick Lopez.

The DVU Detective/Sergeant is Edith Quintero and the Police Officer Investigator is Officer Clement Antonio. The second Officer Position is currently vacant.

F. BRIEF PERSONNEL BIOGRAPHIES

Lieutenant Derrick Lopez joined the Maui Police Department, April 01, 1992 and has been the Crimes Against Persons Unit supervisor since November 1, 2017.

Detective/Sergeant, Edith Quintero, joined the Maui Police Department March 19, 2001 and has been the Domestic Violence Unit supervisor since November 1, 2017.

Officer Clement Antonio joined the Department in December 9, 2002 and has been assigned to the Domestic Violence Unit since June 16, 2015.

G. PARTICIPATING AGENCIES

MPD works collaboratively with community agencies and organizations including the Department of the Prosecuting Attorney, Women Helping Women, Parents and Children Together (PACT), Child and Family Service, Adult Protective Services, Children's Justice Center, Department of Human Services – Child Welfare Services/Child Protective Services, and Maui Fire Department and Medic personnel in supporting victims of domestic violence and sexual assault.

I. PROBABILITY TO IMPROVE THE CRIMINAL JUSTICE SYSTEM

Maui Police Department will continue to collaborate with partner agencies with training efforts for law enforcement, medical personnel, Prosecutors and counselors/advocates working with victims/survivors of domestic violence strangulation, sexual assaults and homicides. Those involved from patrol officers, Detectives/Investigators, Prosecutors and counselor/advocates will continue to build working relationships to ensure services are provided to our victims.

In addition, law enforcement personnel will enhance their practices in responding to victims and investigating domestic violence incidents. Continuous training on strategic investigation techniques on how to properly investigate domestic violence strangulation, sexual assaults and homicides will provide personnel to conduct a thorough investigation for prosecution.

In January 2019, Domestic Violence Unit personnel attended a 1 day Strangulation training in Hilo, Hawai'i. The guest speaker Gael STRACK, co-founder of Alliance for HOPE International provided pertinent and valuable information relating to strangulation. Law enforcement and medical personnel will better understand non-visible signs when dealing with victims of strangulation. Information presented will give law enforcement techniques on how to investigative strangulation incidents, the effects of non-visible signs and obtaining proper evidence needed for a prosecustion.

MPD will collaborate with Parents and Children Together to co-host "Their Voice" formerly called "Her Voice" conference to build that foundation of trust and respect to victim/survivors of domestic violence and law enforcement. This one-day conference will allow victim/survivors to interact and share their experiences and concerns regarding law enforcement's response to domestic violence type cases. This will help law enforcement better understand the trauma victim/survivors endure during a domestic violence encounter.

Through continued collaboration, education and training law enforcement, medical personnel, counselor/advocates and Prosecutors will work together to ensure the prosecution of those offenders who commits these violent crime
