Chair and Members:

Your Governance, Ethics, and Transparency Committee, having met on October 15, 2019, makes reference to County Communication 19-24, from Council Chair Kelly T. King, relating to nominations to boards, committees, and commissions.

By correspondence dated and received on September 30, 2019, the Mayor transmitted a proposed resolution, entitled "RELATING TO THE APPOINTMENT OF J. NALANI KANINAU TO THE BOARD OF WATER SUPPLY FOR THE COUNTY OF MAUI," with a completed application for the nominee. The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of J. Nalani Kaninau to the Board of Water Supply, for a term expiring on March 31, 2022, to fill a vacancy due to the resignation of Michael Nakashima.

Your Committee notes general appointment procedures for boards and commissions are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"), and Chapter 2.41, Maui County Code.

Your Committee further notes specific provisions for the Board of Water Supply are located in Charter Section 8-11.3.

The Council must approve or disapprove Ms. Kaninau's nomination to the Board of Water Supply by November 29, 2019, or the nomination will be deemed approved.

Your Committee met with Ms. Kaninau.

As noted in her board application, Ms. Kaninau is currently employed as a freelance travel director. She is able to attend committee meetings.

A representative of the Mayor said Ms. Kaninau is actively involved in the community. She is a past board member and President of Kihei Canoe Club and a member of Halau Hula Na Maile Ku Honua.

Your Committee notes Ms. Kaninau also currently serves as a board member on the Committee on the Status of Women. Her term is set to expire on March 31, 2023.

Your Committee was satisfied with Ms. Kaninau's application and recommended her nomination be approved.

Your Committee voted 8-1 to recommend adoption of the proposed resolution approving the nomination. Committee Chair Molina, and members Hokama, Kama, King, Lee, Paltin, Sinenci, and Sugimura voted "aye." Committee Vice-Chair Rawlins-Fernandez voted "no."
