- 6 SECTION 1. The legislature finds that increased funding is

- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of _____ or so much
- 10 thereof as may be necessary for fiscal year 2019-2020 and the
- 11 same sum or so much thereof as may be necessary for fiscal year
- 12 2020-2021 to provide funding to support agriculture.
- The sums appropriated shall be expended by the department
