Chair and Members:

Your Governance, Ethics, and Transparency Committee, having met on August 20, 2019, and December 3, 2019, makes reference to County Communication 19-26, from Council Chair Kelly T. King, relating to the Maui County Legislative Package.

Your Committee notes each year the Council may compile a package of proposals and priorities to be presented to the State Legislature.

Your Committee received three proposals for inclusion in the 2020 Maui County Legislative Package, including State bills to: 1) increase State funding to support agriculture to promote economic development, food security, environmental protection, and quality of life; 2) authorize remote schools to receive supplemental categorical funding, in addition to the allocation determined under the weighted student formula, based on their remote status, and to appropriate funds; and 3) require the driver of the lead vehicle, on two-lane roadways where passing is unsafe and five or more vehicles are backed up behind the lead vehicle, to use turnouts and permit vehicles following the lead vehicle, to pass safely.

Increased Funding for Agriculture

By correspondence dated August 5, 2019, Councilmember Shane Sinenci transmitted a proposed resolution entitled "APPROVING FOR INCLUSION IN THE 2020 MAUI COUNTY LEGISLATIVE PACKAGE A STATE BILL TO INCREASE FUNDING FOR AGRICULTURE."

The purpose of the proposed resolution is to approve for inclusion in the 2020 Maui County Legislative Package a proposed State bill, attached to the proposed resolution as Exhibit "A," entitled "A BILL FOR AN ACT RELATING TO AGRICULTURE."

The purpose of the proposed State bill is to increase State funding to support agriculture to promote economic development, food security, environmental protection, and quality of life.

Your Committee notes additional State funding could be used to promote small-scale family farming, establish additional important agriculture lands, update the State's agricultural database, and increase key inspector positions at State airports to identify invasive species.

Your Committee voted 9-0 to recommend adoption of the proposed resolution. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Hokama, Kama, King, Lee, Paltin, Sinenci, and Sugimura voted "aye."

Your Committee is in receipt of a revised proposed resolution, and attached Exhibit "A," incorporating nonsubstantive revisions.

The purpose of the proposed State bill is to authorize remote schools to receive supplemental categorical funding, in addition to the allocation determined under the weighted student formula, based on their remote status, and to appropriate funds for this purpose.

Your Committee notes the weighted student formula for determining school funding has placed small, remote schools, such as Hana High and Elementary School at a disadvantage, resulting in the loss of qualified instructors and the offering of minimum course requirements necessary for graduation.

Your Committee voted 9-0 to recommend adoption of the proposed resolution. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Hokama, Kama, King, Lee, Paltin, Sinenci, and Sugimura voted "aye."

Promotion of Traffic Safety on Two-lane Roadways

A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the Reinventing
2	Education Act of 2004 (Act 51, Session Laws of Hawaii 2004)
3	established a weighted student formula to allocate moneys to
4	schools according to the different costs of educating students
5	with different needs. Despite the intended equitable
6	distribution of funds, the legislature finds that the weighted
7	student formula has placed small, remote schools at a
8	disadvantage. In the case of Hāna high and elementary school,
9	the budgetary shortfall has resulted in the loss of several
10	well-qualified teachers and has threatened the school's ability
11	to offer minimum course requirements for students to earn high
12	school diplomas. If Hāna high school is unable to offer its
13	students the requisite courses for graduation, those students
14	will have to endure a nearly forty-mile, two-hour drive away, to
15	the next closest public high school, King Kekaulike high school.
16	The legislature finds that despite the current economic
17	situation, remote schools should be funded to retain the minimal
18	personnel and resources necessary to graduate students. One way

- 1 to address this is to allow these schools to receive 2 supplemental funding based on their remote status. The purpose of this Act is to authorize supplemental 3 4 categorical funding for remote schools. SECTION 2. WHEREAS, unsafe driving conditions may be created on two-lane roadways where the lead vehicle is moving slowly, with a back-up of vehicles behind it, and traffic moving in the opposite direction makes it a hazard to pass; and

WHEREAS, this situation is frequently encountered on the road to Hāna, where visibility around turns is inhibited because of the natural contours of the road; and

WHEREAS, it would promote traffic safety to require the driver of the lead vehicle with five or more vehicles behind it to turn off the roadway at the nearest place designated as a turnout or wherever sufficient area for a safe turnout exists, to allow the vehicles following it to proceed; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That the proposed State bill, attached as Exhibit "A," to promote traffic safety on two-lane roadways, is approved for inclusion in the 2020 Maui County Legislative Package; and
- 2. That certified copies of this Resolution be transmitted to the Governor of the State of Hawaii, the President of the State Senate, the Speaker of the State House of Representatives, the County's delegation to the State Legislature, the Mayor of the County of Maui, and the Corporation Counsel.

RELATING TO TRAFFIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that unsafe driving
- 2 conditions may be created on two-lane roadways where the lead
- 3 vehicle is moving slowly, with a back-up of vehicles behind it,
- 4 and traffic moving in the opposite direction makes it unsafe to
- 5 pass. This situation is frequently encountered on Hāna Highway,
- 6 between Mile Marker 00 and Mile Marker 34, where visibility
- 7 around turns is inhibited because of the natural contours of the
- 8 road. The purpose of this Act is to require the driver of the
- 9 lead vehicle on Hāna Highway, between Mile Marker 00 and Mile
- 10 Marker 34, to use turnouts and allow vehicles to pass, thereby
- 11 promoting traffic safety on this roadway.
- SECTION 2. Section 291C-41, Hawaii Revised Statutes, is
- 13 amended by adding a new subsection d to read as follows:
- 14 "§291C-41 Drive on right side of roadway; exceptions. (a)
- 15 Upon all roadways of sufficient width a vehicle shall be driven
- 16 upon the right half of the roadway, except as follows:

- 1 (1) When overtaking and passing another vehicle

- 4 (2) When an obstruction exists making it necessary to

- 17 then available for traffic, or as close as practicable to the
- 18 right-hand curb or edge of the roadway, except when overtaking
- 19 and passing another vehicle proceeding in the same direction or
- 20 when preparing for a left turn at an intersection or into a
- 21 private road or driveway.

- 1 (c) Upon any roadway having four or more lanes for moving
- 2 traffic and providing for two-way movement of traffic, no
- 3 vehicle shall be driven to the left of the center line of the
- 4 roadway, except when authorized by official traffic-control
- 5 devices designating certain lanes to the left side of the center
- 6 of the roadway for use by traffic not otherwise permitted to use
- 7 such lanes, or except as permitted under subsection (a)(2). This
- 8 subsection shall not be construed to prohibit the crossing of
- 9 the center line in making a left turn into or from an alley,
- 10 private road, or driveway.
- (d) Upon Hāna Highway, between Mile Marker 00 and Mile
- Marker 34, where passing is unsafe because of traffic in the
- 13 opposite direction or other conditions, any vehicle proceeding
- 14 upon the roadway, behind which five or more vehicles are formed
- in line, must turn off the roadway at the nearest place
- 16 designated as a turnout by signs erected by the authority having
- 17 jurisdiction over the roadway, or wherever sufficient area for a
- 18 safe turnout exists, in order to permit the vehicles following
- 19 <u>it to proceed."</u>
