Chair and Members:

Your Economic Development and Budget Committee, having met on December 5, 2019, makes reference to County Communication 19-281, from Council Vice-Chair Keani N.W. Rawlins-Fernandez, relating to amendments to Appendix A, Grants and Restricted Use Revenues -Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year ("FY") 2020.

By correspondence dated September 26, 2019, the Budget Director transmitted a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES – SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, EMERGENCY MANAGEMENT AGENCY (STATE HOMELAND SECURITY GRANT (SHSG) PROGRAM)."

The purpose of the proposed bill is to amend Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs, FY 2020 Budget, by increasing the grant appropriation for the Emergency Management Agency, State Homeland Security Grant (SHSG) Program, by \$204,000. The SHSG program provides funds to prevent, deter, respond to, and recover from threats and incidents of terrorism and supports the County of Maui in leveraging funding to support National Preparedness System initiatives.

The Emergency Management Administrator said the grant will be used for various projects for the Department of Fire and Public Safety, the

Department of Police, and the Department of Management's Information Technology Services Division.

The Budget Director explained the original appropriation of \$500,000 was an estimate based on the amount awarded for this grant in FY 2019. This year's award was determined after the FY 2020 Budget was finalized.

Your Committee voted 6-0 to recommend passage of the proposed bill on first reading. Committee Chair Rawlins-Fernandez and members Kama, Lee, Molina, Sinenci, and Sugimura voted "aye." Committee Vice-Chair King and members Hokama and Paltin were excused.

A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES - SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, EMERGENCY MANAGEMENT AGENCY (STATE HOMELAND SECURITY GRANT (SHSG) PROGRAM)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4988, Bill No. 36 (2019), Draft 1, as amended, "Fiscal Year 2020 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2020, is hereby amended as it pertains to the Emergency Management Agency, by increasing the appropriation for the State Homeland Security Grant (SHSG) Program by \$204,000, to read as follows:

"1. Emergency Management Agency

a. Emergency Management Performance Grant (EMPG)		100,000
b. State Homeland Security Grant (SHSG) Program	[500,000]	<u>704,000</u> "

SECTION 3. This Ordinance shall take effect upon its approval.
