Chair and Members:

Your Economic Development and Budget Committee, having met on December 5, 2019, makes reference to County Communication 19-281, from Council Vice-Chair Keani N.W. Rawlins-Fernandez, relating to amendments to Appendix A, Grants and Restricted Use Revenues - Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year ("FY") 2020.

By correspondence dated September 12, 2019, the Budget Director transmitted a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES - SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF HOUSING AND HUMAN CONCERNS (VOLUNTARY CONTRIBUTIONS)."

The purpose of the proposed bill is to amend Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs, FY 2020 Budget, by adding a new grant appropriation under the Department of Housing and Human Concerns entitled "Voluntary Contributions" in the amount of \$80,000, recognizing opportunities for seniors and family members to voluntarily contribute to the Office on Aging for services they receive.

According to the Budget Director's letter, the Office on Aging is required by federal law to allow for voluntary contributions. However, these contributions must be used for the services for which they were collected.
