Chair and Members:

Your Planning and Sustainable Land Use Committee, having met on November 20, 2019, makes reference to County Communication 19-265, from the Planning Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE CHANGE OF ZONING FROM R-2 RESIDENTIAL TO B-2 COMMUNITY BUSINESS FOR PROPERTIES IDENTIFIED AS TAX MAP KEYS (2) 3-9-003:003 AND (2) 3-9-003:005, LOCATED AT 30 ALAHELE PLACE AND 33 AUHANA ROAD, KIHEI, MAUI, HAWAII."

The purpose of the proposed bill is to grant a Change in Zoning from R-2 Residential District to B-2 Community Business District for approximately 2.5 acres, identified for real property tax purposes as tax map keys (2) 3-9-003:003 and (2) 3-9-003:005, situated at Kihei, Maui, Hawaii ("property"), for Nation Land Company, LLC ("landowner").

Your Committee notes the landowner initially proposed a project that included improvements to the property and an additional parcel. The landowner required a Special Management Area Use Permit, a Conditional Permit, and a Change in Zoning to proceed with that project.

After the Maui Planning Commission reviewed that project, the landowner withdrew the applications for the Special Management Area Use Permit and the Conditional Permit and modified their Change in Zoning application to match the proposed use of the property.

The landowner is no longer proposing to improve the property. Instead, by receiving the Change in Zoning to B-2 Community Business District, the landowner will have more flexibility to operate a plant nursery and a bakery on the property.

The Planning Director said that if the landowner decides to construct or modify structures on the property, they will need to obtain a Special Management Area Use Permit.

Your Committee amended the proposed bill by adding three conditions to:

- 1. Prohibit transient accommodations on the property;
- 2. Limit the uses allowed on the property; and
- 3. Set a maximum height of 45 feet for any structure on the property.

Your Committee voted 6-0 to recommend passage of the revised proposed bill on first reading, recordation of the unilateral agreement, and filing of the communication. Committee Chair Paltin, Vice-Chair Sinenci, and members King, Lee, Molina, and Rawlins-Fernandez voted "aye." Committee member Sugimura was excused.

Your Committee is in receipt of a revised proposed bill, entitled "A BILL FOR AN ORDINANCE TO CHANGE ZONING FROM R-2 RESIDENTIAL DISTRICT TO B-2 COMMUNITY BUSINESS DISTRICT (CONDITIONAL ZONING) FOR PROPERTIES IDENTIFIED AS TAX MAP KEYS (2) 3-9-003:003 AND (2) 3-9-003:005, LOCATED AT 30 ALAHELE PLACE AND 33 AUHANA ROAD, KIHEI, MAUI, HAWAII," approved as to form and legality by the Department of the Corporation Counsel, incorporating your Committee's recommended revisions and nonsubstantive revisions.

Your Committee also received an agreement entitled "UNILATERAL AGREEMENT AND DECLARATION FOR CONDITIONAL ZONING," executed by the landowner, and approved as to form and legality by the Department of the Corporation Counsel.

A BILL FOR AN ORDINANCE TO CHANGE ZONING FROM R-2 RESIDENTIAL DISTRICT TO B-2 COMMUNITY BUSINESS DISTRICT (CONDITIONAL ZONING) FOR PROPERTIES IDENTIFIED AS TAX MAP KEYS (2) 3-9-003:003 AND (2) 3-9-003:005, LOCATED AT 30 ALAHELE PLACE AND 33 AUHANA ROAD, KIHEI, MAUI, HAWAII

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. In accordance with Chapter 19.510, Maui County Code, a change of zoning from R-2 Residential District to B-2 Community Business District is granted for properties situated at Kihei, Maui, Hawaii, identified for real property tax purposes as tax map keys (2) 3-9-003:003 and (2) 3-9-003:005, comprising approximately 2.5 acres, as more particularly described in Exhibit "A," which is a land description, and Exhibit "B," which is Land Zoning Map L-5124.

SECTION 2. In accordance with Section 19.510.050, Maui County Code, the zoning granted by this ordinance is subject to the conditions stated in Exhibit "C," which is the list of conditions of zoning, and Exhibit "D," which is the Unilateral Agreement and Declaration for Conditional Zoning.

SECTION 3. This ordinance takes effect upon its approval.



UNILATERAL AGREEMENT AND DECLARATION FOR CONDITIONAL ZONING

December, INDENTURE, made this 11th THIS day of 2019 , hereinafter referred to as "DECLARATION" or "UNILATERAL AGREEMENT", by Nation Land Company, LLC, an Ohio limited liability company whose principal place of business is located in Kihei, Maui, Hawai'i, and whose mailing address is 35 Auhana Kihei, Hawai`i 96753, hereinafter Road, referred to as "DECLARANT", and who is the owner of that certain parcels located at Kihei, Maui, Hawai'i, comprised of approximately 2.5 acres, and identified for real property tax purposes by Tax Map Key No(s). (2)3-9-003:003 and (2) 3-9-003:005, hereinafter referred to as "PROPERTY".

WITNESSETH:

WHEREAS, the Council of the County of Maui, State of Hawai`i, hereinafter referred to as "Council", is considering the establishment of zoning for the Property, comprised of approximately 2.5 acres, which is more particularly described in Exhibit "1", which is attached hereto and made a part hereof, and which is more particularly identified in Land Zoning Map No.

EXHIBIT D

L-5124, which is attached hereto and made a part hereof as Exhibit 2''; and

WHEREAS, the Council recommends through its Planning and Sustainable Land Use Committee, Committee Report No. _____, that said establishment of zoning be approved for passage on first reading subject to certain conditions, pursuant to Section 19.510.050, Maui County Code; and

WHEREAS, the Declarant has agreed to execute this instrument pursuant to the conditional zoning provisions of Section 19.510.050, Maui County Code;

NOW, THEREFORE, the Declarant makes the following Declaration:

1. That this Declaration is made pursuant to the provisions of Section 19.510.050, Maui County Code, relating to conditional zoning;

That until written release by the County of Maui, the 2. Property, and all parts thereof, is and shall be held subject to the covenants, conditions and restrictions which shall be effective as to and shall run with the land as to the Property, from and after the recording of this Declaration with the Bureau of Conveyances or the Land Court of the State of Hawai`i, without the execution, delivery or recordation of any further deed, instrument, document, agreement, declaration, covenant or the like with respect thereto by the Declarant, the County of Maui, or any heir, devisee, executor, administrator, personal representative, successor, and assign; that the acquisition of any right, title or interest in or with respect to the Property by any person or persons, entity or entities, whomsoever, shall be deemed to constitute the acceptance of all of the covenants, conditions and restrictions of this Declaration by such person or persons, entity or entities; and that upon any transfer of any right, title or interest in or with respect to the Property the same shall be subject to, and the transferee shall assume and be bound and obligated to observe and perform all of the covenants, conditions and restrictions of this Declaration;

3. That this Declaration and all of the covenants, conditions and restrictions contained herein shall continue to be effective as to and run with the land in perpetuity, or until the Declarant notifies the appropriate County Department that any of said covenants, conditions and restrictions are satisfied by the Declarant, and the appropriate County Department verifies

the satisfaction and provides a written release of the covenant, condition or restriction;

4. That the term "Declarant" and any pronoun in reference thereto, wherever used herein, shall be construed to mean the singular or the plural, the masculine or the feminine, or the neuter, and vice versa, and shall include any corporation, and shall be held to mean and include the "Declarant", the Declarant's heirs, devisees, executors, administrators, personal representatives, successors, and assigns;

5. That this Declaration shall become fully effective on the effective date of the zoning ordinance approving the establishment of B-2 Community Business District zoning and this Declaration shall be recorded in the Bureau of Conveyances or Land Court of the State of Hawai`i;

6. That the Declarant agrees to develop said Property in conformance with the conditions set forth in Exhibit "3", which is attached hereto and made a part hereof and which shall be made a part of the zoning ordinance;

7. That the conditions imposed are reasonable and rationally relate to the objective of preserving the public health, safety and general welfare and such conditions fulfill the need for the public service demands created by the proposed use;

AND IT IS EXPRESSLY UNDERSTOOD AND AGREED that until released in writing by the County, the conditions imposed in this Declaration shall run with the land identified hereinabove and shall bind and constitute notice to all subsequent owners, lessees, grantees, assignees, mortgagees, lienors and any other persons who claim an interest in said land, and the County of Maui shall have the right to enforce this Declaration by appropriate action at law or suit in equity against all such persons, provided that the Declarant or its successors and assigns may at any time file a petition for the removal of the conditions and terminate this Unilateral Agreement, such petition to be processed in the same manner as petitions for change in zoning.

This Declaration may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same Declaration. Each person signing this Unilateral Agreement represents and warrants that he or she is duly authorized and has legal capacity to execute and deliver this Unilateral Agreement. Each party represents and warrants to the other that the execution and delivery of this Unilateral Agreement and the performance of such party's obligations hereunder have been duly authorized and that this Unilateral Agreement is a valid and legal agreement binding on such party and enforceable in accordance with its terms.




