A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANTS AND RESTRICTED USE REVENUES - SCHEDULE OF GRANTS AND RESTRICTED USE REVENUES BY DEPARTMENTS AND PROGRAMS, OFFICE OF THE MAYOR (COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUL

SECTION 1. Ordinance No. 4988, Bill No. 36 (2019), Draft 1, as amended, "Fiscal Year 2020 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2020, is hereby amended as it pertains to the Office of the Mayor, Community Development Block Grant (CDBG) Program, by 1) adding a project and project description for Ka Hale A Ke Ola Homeless Resource Centers, Inc., KHAKO Renewal Project Phase 2, Building 6; 2) adding a project and project description for Big Brothers Big Sisters Hawaii, Inc., Hale Makana Mentor Center Restoration; and 3) deleting the project and project description for Hale Makua Health Services, Hale Makua Wailuku Roof Resurfacing and Recoating, to read as follows:
