WHEREAS, the West Maui Community Plan Advisory Committee requires additional time to complete a thorough review of the draft community plan and forward its recommended revisions to the Planning Director; now, therefore,

**BE IT RESOLVED** by the Council of the County of Maui:

1. That the West Maui Community Plan Advisory Committee is granted up until May 19, 2020 to forward its recommended revisions on the draft West Maui Community Plan to the Planning Director; and
2. That certified copies of this resolution shall be transmitted to the Mayor, the Planning Director, and the West Maui Community Plan Advisory Committee.
