Thank you for the opportunity to respond to your questions in response to the Economic Development & Budget Committee letter, dated December 5, 2019. As requested, we are providing the following responses to your request in relation to:

1. Please send an itemized breakdown of costs to the County of Maui for all activity related to Mauna a Wakea under the Memorandum of Understanding you referenced in your letter dated September 3, 2019.

Below are the itemized expenses of personnel overtime, airline travel, and the shipping of vehicles to the County of Hawaii totaling \$100,612.96.

Personnel overtime/ contractual obligations:	\$86,330.57
Transportation:	\$9,881.77

Shipping of Equipment: \$4,400.62

AMOUNT DUE: \$100,612.96

2. Have these costs been reimbursed to the County of Maui by the County of Hawai'i?

The costs are being reimbursed by the Department of the Attorney General. The check was mailed to the Department on Monday, December 9, 2019 and should be arriving this week.

3. If these costs have not been reimbursed, what is the anticipated date of reimbursement?
