AMENDMENT TO THE FISCAL YEAR 2020 BUDGET SUBJECT: (DEPARTMENT OF FIRE AND PUBLIC SAFETY, FIRE/RESCUE OPERATIONS PROGRAM)

On behalf of the Department of Fire and Public Safety, I am transmitting the attached proposed bill for the purpose of amending the operating budget for the Fire/Rescue Operations Program.

In light of all the brush fires since July 1, 2019, the Department of Fire and Public Safety has incurred additional expenses related to helicopter and heavy equipment costs. The proposed amendment would increase the appropriation in Category B (operations) for the Fire/Rescue Operations Program by \$600,000.

Also, attached is a Certification of Additional Revenues for Fiscal Year 2020 certifying the availability of General Fund Carryover/Savings in the amount of \$600,000 to fund this request.

A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2020 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF FIRE AND PUBLIC SAFETY, FIRE/RESCUE OPERATIONS PROGRAM; TOTAL OPERATING APPROPRIATIONS; AND TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUL:

SECTION 1.
