INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF Subject: HAWAII, DEPARTMENT OF HEALTH (GET-37)

At your request, the Maui Police Department has prepared a detailed anticipated cost breakdown of fees and costs associated with the subject project. Although a per annum breakdown beginning October 1, 2019 through October 1, 2023 was requested, the fluctuating number of suicides that occur each year have provided us with no clear pattern with which to forecast costs. Instead, we are able to provide you with a fixed average cost per year based on five years of historical data.

There has also been no accounting in the cost report for salary increases of assigned employees as HGEA step movements are currently frozen. Once steps are reinstated, a slight upward adjustment of the man-hour costs could be applied. We do believe the costs provided, however, are an accurate average of chargeable fees and actual costs to be incurred by the County throughout the project period.
