This AMENDMENT NO. 3 TO CONTRACT is made and entered into by and between the COUNTY OF MAUI, a political subdivision of the State of Hawaii, whose business address is 200 South High Street, Wailuku, Maui, Hawaii 96793, hereinafter referred to as the "County", and MAUI RESOURCE RECOVERY FACILITY, LLC, a Delaware limited liability company, whose mailing address is 5780 Fleet Street, Suite 310, Carlsbad, California 92008, hereinafter referred to as the "Contractor." County and Contractor shall hereinafter be referred to collectively as the "Parties".

RECITALS:

1. WHEREAS, the County and the Contractor entered into the following Contract and Amendment(s), if any, with certified availability of funds in the amount indicated and time of performance as indicated:

- 2. WHEREAS, the Contract and any Amendment(s) thereto listed above shall be hereafter collectively referred to as "Contract"; and
 - 3. WHEREAS, the Contract is on file with the Director of Finance; and

WHEREAS, the Contractor has represented to the County, and the County has acknowledged the execution of the contract has been impacted by reasons beyond reasonable control of the Contractor;

WHEREAS, County acknowledges that an amendment to the contract to provide additional time to the Contractor to achieve specific milestones is interest of the County

4. WHEREAS, the Parties now desire to amend the Contract.

NOW, THEREFORE, the Parties mutually agree to amend the Contract as follows:

1. Section 3.07(d) is amended in full as follows:

"(d) If the conditions set forth in this Article are not completed, waived, or extended by written agreement within seventy-eight (78) months of the Effective Date and MRRF is not diligently pursuing such permits, licenses, and other approvals, the County shall have the option to terminate the Agreement without triggering the default provisions of this Agreement or incurring any liability under this Agreement."

2. Section 9.01 is amended in full as follows:

"MRRF shall have until June 30, 2020 ("Offtake Contract Milestone Date") to execute a binding contract with Maui Electric Company for sale of electricity or renewable gaseous fuel ("Offtake Contract") generated by MRRF's processing of Acceptable Waste, which deadline may be extended at the sole discretion of the County. In the event the contractor achieves the Offtake Contract Milestone Date, the Parties shall negotiate in good faith a reasonable milestone to achieve the Commercial Operations Date. In the event the Offtake Contract is not fully executed by the Offtake Contract Milestone Date, either Party may terminate the Agreement with notice to the other Party without triggering the default provisions of this Agreement or incurring any liability under this Agreement."

The entire Contract, as amended herein, shall remain in full force and effect.

IN WITNESS WHEREOF, the Parties execute this Amendment No. 3 by their signatures, on the dates below, to be effective as of the date of last signature hereto.
