SUBJECT: HAWAIIAN CULTURAL RESTORATION REVOLVING FUND ANNUAL REVENUES AND EXPENDITURES REPORT

Pursuant to Chapter 3.38.030, the Director of Finance is required to transmit to council a detailed report of the revenues credited to, and expenditures made from, the revolving fund during the preceding year on or before March 1 of each year.

The revolving fund balance as of December 31, 2018 was \$420,451.32. Revenues for Calendar Year 2019 was \$291,265.34. There were no expenditures from the fund in 2019. (Appropriations from the fund require Maui County Council approval by ordinance.) The revolving fund balance as of December 31, 2019 is \$711,716.66.

The detailed report is enclosed for your reference. The Base Rent is \$15,000 per month and the Additional Rent is based on 83.05% of the Monthly Gross Receipts less the Base Rent. The Additional Rent is invoiced and paid one month in arrears.

Also, please be advised that the Concessionaire is on a Month-to-Month tenancy as of the January 1, 2018, and through June 30, 2022. Either party may terminate the Concession Agreement upon 30 days' written notice to the other Party.
