


#### **EP&S Mission Statement**

- Contractual Services: Recycling/Diversion Materials and Organics Collection, Processing, Education; Electronics; UMO; Household Hazardous Waste; Appliances; Engineering; AV Towing, Storage, Disposal; JVDAP; Regional Collection Events
- Other, Other Services: Overhead; AV Cleanouts; Sweeps/Special Tows; Community Cleanups; Advertising; Signage; Hauling
- Grants: Recycling Grants; Malama Maui Nui Keep Maui Beautiful

- Expanding and Streamlining Junk Vehicle Disposal Assistance Program
- Improving abandoned vehicles response

### Junk Vehicle Disposal Assistance Program Expansion

- Kickoff: March 16!
- Double Capacity: 2 Vehicles per year (up from 1)
- Streamlined process: All documents submitted at Hammerhead, not to DMV
- Heavy Saturation JVDAP and AV education: Radio, print, web ad and education campaign

### **Abandoned Vehicles Response**

- FY19: 2727 Reports, 1766 Tows
- FY20 YTD: 1140 Tows

With additional staff, adequate funding, and larger office space, EP&S could be empowered to:

- Improve field response and decrease towing delays
- Develop and administer a plan to add towing to JVDAP services
- Enhance services on all three islands of Maui, Molokai, Lanai
- Continue advertising, education, and monitoring
- Expected to decrease AV's by 25%

### **Community Cleanups and Litter Control**

#### FY20

- Assisted with requests for tires, metals and rubbish disposal; Cost: \$15,000
- Initiated propane tank collections, anti-freeze collections with UMO

#### **Future Goals**

- Develop Community Cleanup Assistance Grant program for collection, hauling, and disposal
- Explore expansion for central and regional recycling collection events for appliances, scrap metal, tires, auto batteries, propane tanks

### FY 2020 Recycling Section Overview

- Strategy: Refocus on Zero Waste principles → Reduce + Reuse
- Operations: Maintain recycling programs amidst global challenges
  - Dropbox Recycling Centers, Curbside Recycling, County Office Paper, Electronics, HHW, Disaster Debris Recovery, Organics Processing
- **Research:** Exploring local options for recycling and waste conversion of certain materials
- Education:
  - County Recycling Guide; Talking Trash Newsletter
  - "Wishcyling/Recycle Right" education campaign: Radio, print, web ads, magnets, new signage
  - BYO! Resuables Campaign
  - Zero Waste Messaging
- Implementation and Enforcement:
  - Polystyrene Ban
  - Single-Use Plastic Foodware Ordinance?
- Community Support: Annual Recycling Grants Program
