In response to the Economic Development & Budget Committee meeting of April 15, 2020, please find Department of Water Supply's written response to the committee members' questions as follows:

1. Proposed 5% budget cut:

Answer:

See Attachment 1. Please note that this list was revised to increase watershed grant funding and reduce travel expenses. We also excluded deferral of the Hydraulic Cylinder Servicer.

2. Consider alternatives to \$16M budgeted electrical expenses:

Answer:

We agree that our electrical expenses are exorbitant. We have historically analyzed potential alternatives. Unfortunately, we are faced with challenges in capacity (availability of land for photovoltaic panels), reliability (renewable energy battery capacity), and regulations (related to photovoltaic farms, hydroelectric turbines, etc.). Prior administrations have devoted a great deal of resources to assess feasibility.

The Department of Water Supply pumping operations provides 70% of total system demand for Maui island and 100% for Molokai island. Our pumps range from 75-horsepower to 700-horsepower motors and they pump water from deep underground aquifers into our distribution tanks.

Peak pumping cycles follow system demand usage which is early morning 4 am to about 11 am and again in the afternoon/evening 4 pm to 10 pm. During those peak hours our electrical load ranges from 1 to 3 Megawatts (MW) of electricity and 3 to 4 MW during dry summers when we pump to upcountry. We have investigated solar (photovoltaic PV) power but our sites are too small for the required number of solar panels.

For example, for a 1 MW solar power plant installation, the solar farm land requirements would be about 4 acres to 5 acres of land.

Energy would only be available during full sun light hours. Early morning and after sunset, we would need a cluster of batteries to operate the facility during the night. We have evaluated collaborating with private companies for possible partial power purchase agreements, but we will still need Maui/Hawaiian Electric to provide power to make up the difference. Also switching, blending, and mixing sources of large power grids are very complicated and costly. This emerging technology is still relatively new and is improving with questionable reliability.

Since 2005, the Department has been upgrading its pumps and motors with premium efficient models to save electricity and this has helped control the rise of electrical costs.

In coordination with Maui/Hawaiian Electric, the Water Department has enrolled many of its facilities in their Fast DR (Direct Response) program, which credits the Department for participation in reducing loads during power grid crises to avoid outages.

Going forward one of our goals is to hire an energy consultant to assess feasible alternatives to reduce our electricity costs.

3. How will DWS maintain the intake for Wailuku Water Company after county purchases the system?

Answer:

DWS intends to hire an engineering consultant to assess the condition of the system and provide estimated costs associated with necessary repair and maintenance work. Until necessary repair work has been completed, DWS will likely contract out ongoing maintenance.

4. Fourth block rates for General Water Consumers:

Answer:

The tiers are based on typical water usage patterns for customer classes. With single-family customers, there is a typical water usage pattern for single family customers that we can design rates around, mainly around the size of typical single family meters -5/8" or 34". With General Customers - there is no typical "General Customer" since this is a broad category of small commercial, multi-family, hotels, restaurants, etc., so we could not design a rate structure based on typical water usage patterns for all of these types of customers without getting a lot more customer usage data. And even with the data it would be difficult to design rates for say a hotel class since there are so many different sizes of hotels. This is why commercial customers are almost always on a uniform rate.

In Maui's case we have kept the first two tiers to replicate single-family with the recognition that there are small businesses on 5/8" or 34" meters that use water in similar patterns to single family. But outside of this customer category, all other customers have very different usage patterns and of course usage volumes. The third tier in Maui's rate structure for General Customers is effectively a uniform rate.

Customers in the "General Water Consumers" category tend to have the highest bills. Please note that this category includes apartment buildings and businesses—entities involving Maui residents.

We can address this more in the rate study.

5. Advertising DWS water as an alternative to bottled water:

<u>Answer:</u> We will look into this.

6. Sharing data regarding sewer and water consumption:

<u>Answer:</u> Director Pearson's office will share consumption information as it becomes available.

7. List of projects in CBS-2299:

Answer:

CBS-2299 includes improvement related projects for existing infrastructure. The water source projects that Director Pearson referred to are for source expansion.

9. Grants:

Answer:

DWS supports general fund appropriation for watershed grants. Although DWS proposes reduction of watershed grant appropriations in 2021, please understand that it is difficult to continue to provide clean and safe drinking water (under clean and safe conditions) if we significantly reduce funding for daily operations. At least temporarily, we could reduce grant funding without severe impacts to the watershed partners and without jeopardizing DWS' operational health and safety.

10. Can travel be reduced?
