# DEPARTMENT OF FIRE & PUBLIC SAFETY FY 2021 BUDGET PRIORITIES

- 1. Ensure that our personnel have the appropriate equipment to provide firefighting, rescue, and first-responder emergency services in order to save lives and property from fires and other emergencies arising on land, sea, and hazardous terrain, including the mitigation and stabilization of hazardous materials and incidents relating to the same.
- 2. Provide our department members with the most effective and efficient emergency response preparation and training for fire suppression, technical rescue, ocean rescue emergency medical service, and hazardous material incidents, as well as support and promote of professional development for all personnel.
- 3. Provide the supplies and equipment necessary to perform emergency functions effectively and safely; issue, maintain, and provide training for respiratory and other personal protective equipment; manage fitness programs; provide rehabilitation and medical monitoring during large and/or prolonged incidents; and administer critical incident stress management as needed.
- 4. Prioritize the service and maintenance of department vehicles, equipment and facilities to prolong service life, and extend the timeline for replacement.
- 5. Provide trained and qualified personnel to inspect all schools, hospitals, and commercial buildings, and seek the correction of any hazards found; educate residents in fire prevention practices; review plans for commercial buildings to ensure all fire safety features are included before the building is built; review, update and enforce the State and County Fire Code; investigate fires to determine their origin and cause, use the information for future fire hazard awareness and for the prosecution of arson cases; and maintain inspection records and reports to measure results.

#### **DHHC FY21 Budget Priorities**

The Department recommends that as a first measure to achieve 5% reduction in overall budget, all new line item grants and any expansion of grant funding from FY20 levels be deleted. Such strategy would result in a savings of approximately \$1,728,000 from Human Concerns. Maintaining funding at FY20 levels for the First Time Homebuyers' Program will add \$1,000,000 to savings (Total \$2,728,000). This is more than 5% of the Department's total budget.

If further reductions are required, the Department would focus on reducing our grant funding to non profits, and would provide the Council with recommendations for priority funding. The Department's position regarding grant funding is that strategic reductions based on community need priorities, program performance, and relevant program specific budgets would be preferable to an across-the board reduction to all grantees. Funding could be reduced or eliminated from programs that consistently underperform and struggle to show program and financial accountability. Programs can also be prioritized so there is less reduction in funding to programs that meet high demand community needs. Top priorities would include homeless shelters and outreach, substance abuse treatment, and food security. Grant funding for grantee capital improvement projects could also be reduced or eliminated in this year's budget given the gravity of our current Covid-19 crisis.

The Department respectfully requests proposed expansion positions and equipment related to providing direct services and assistance to the community be retained.
