Chair and Members:

Your Governance, Ethics, and Transparency Committee, having met on February 18, 2020, February 21, 2020, and February 25, 2020, makes reference to County Communication 19-24, from Council Chair Kelly Takaya King, relating to nominations to boards, committees, and commissions ("boards").

By correspondence dated and received on January 30, 2020, the Mayor transmitted the following:

- 1. A proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE BOARD OF VARIANCES AND APPEALS FOR THE COUNTY OF MAUI," with a completed application for the nominee. The purpose of the proposed resolution is to approve or disapprove the Mayor's nomination of Caron Green to the Board of Variances and Appeals for a term beginning on April 1, 2020, and expiring on March 31, 2025.
- 2. A proposed resolution, entitled "APPOINTMENT OF MEMBERS TO THE MAUI COUNTY CULTURAL RESOURCES COMMISSION," with completed applications for the nominees. The purpose of the proposed resolution is to approve or disapprove the Mayor's nominations of Emily Spenser, Brandis Sarich, and Marinel Yumol to the Maui County Cultural Resources Commission for terms beginning on April 1, 2020, and expiring on March 31, 2025.

3. proposed resolution, entitled "APPOINTMENT OF MEMBERS TO THE URBAN DESIGN REVIEW BOARD FOR THE COUNTY OF MAUI," with completed applications for the nominees. The purpose of the proposed resolution is to approve disapprove the Mayor's nominations Christopher Curtis (Land Architect) and Circle-Woodburn (Alternate) (Land Architect) to the Urban Design Review Board for terms beginning on April 1, 2020, and expiring on March 31, 2025.

Your Committee notes general appointment procedures for boards are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code.

The Mayor is required to submit names of nominees to the Council not less than 60 days and not more than 70 days before the prior members' terms expire. Except for the Urban Design Review Board, the Council must approve or disapprove the nominees within 60 days thereafter. If the Council fails to approve or disapprove any of the Mayor's nominees within the time period provided, the nominee will be deemed appointed to fill the vacancy. If the Council disapproves a nominee, the Mayor will be immediately notified.

Your Committee notes board nominations were transmitted on January 30, 2020, by the Mayor. Accordingly, the Council has until March 30, 2020, to approve or disapprove the Mayor's nominees, or the nominees will be deemed appointed.

Your Committee met with Maui County Cultural Resources Commission nominee Emily Spenser. Ms. Spenser said she has spent much of her life in appreciation for her culture, which is demonstrated not only by her 23 years of study with a halau, but also by her bachelor and master's degrees in Hawaiian studies. Ms. Spenser does not see any issues with her attendance at the meetings, and she feels her education and

experience give her a unique combination of skills related to cultural knowledge and the issues facing Maui County.

Your Committee met with Urban Design Review Board nominee Christopher Curtis. Mr. Curtis noted that he has stepped back into a consulting role with his company, so he now has more time available to serve and attendance should not be an issue. He noted that he has significant experience in the field of landscape architecture and feels this will allow him to contribute to the decisions of the Board.

Your Committee met with Maui County Cultural Resources Commission nominee Marinel Yumol. Ms. Yumol noted her long history on the island of Lanai, completion of a community leadership program, and service on several boards. Your Committee raised concerns that she would have to recuse herself from almost all Lanai decisions that come before the Commission because of her employer, leaving Lanai unrepresented. Your Committee feels that Ms. Yumol is very qualified, but that this is not the correct board for her to serve on at this time.

Your Committee met with Urban Design Review Board nominee Joshua Circle-Woodburn. Mr. Circle-Woodburn said he is excited to be able to help the Board with their design and review process. He does not anticipate any issues with attendance as his employer is willing to accommodate his schedule. Mr. Circle-Woodburn stated he would recuse himself if any issues related to his company came before the Board.

Your Committee recommended five nominees be approved for the boards and terms for which they have been nominated. Your Committee was satisfied with the background of the nominees and expressed its gratitude to the nominees for volunteering to serve the community. Your Committee recommended Exhibit "B" to the proposed resolutions be revised accordingly.

Your Committee recommended disapproval of Marinel Yumol to the Maui County Cultural Resources Commission after conducting deliberations on the nomination. Your Committee recommended Exhibit "C" to the proposed resolution be revised accordingly.

Your Committee voted 8-0 to recommend approval of the nominations of Caron Green to the Board of Variances and Appeals; Emily Spenser and Brandis Sarich to the Maui County Cultural Resources Commission; and Christopher Curtis (Land Architect) to the Urban Design Review Board. Committee Chair Molina, Vice-Chair Rawlins-Fernandez, and members Hokama, Kama, King, Lee, Paltin, and Sugimura voted "aye." Committee member Sinenci was excused.
