Your Governance, Ethics, and Transparency Committee, having met on February 18, 2020, February 21, 2020, and February 25, 2020, makes reference to County Communication 19-24, from Council Chair Kelly Takaya King, relating to nominations to boards, committees, and commissions ("boards").

terms will begin on April 1, 2020 and expire on March 31, 2025.

Your Committee notes general appointment procedures for boards are outlined in Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"), and Chapter 2.41, Maui County Code.

The Mayor is required to submit names of nominees to the Council not less than 60 days and not more than 70 days before the prior members' terms expire. Except for the Kula Agricultural Park Committee, Maui Redevelopment Agency, and Urban Design Review Board, the Council must approve or disapprove the nominees within 60 days thereafter. If the Council fails to approve or disapprove any of the Mayor's nominees within the time period provided, the nominee will be deemed appointed to fill the vacancy. If the Council disapproves a nominee, the Mayor will be immediately notified.

Your Committee notes board nominations were transmitted on January 22, 2020, by the Acting Mayor on the Mayor's behalf to meet established deadlines because the Mayor was out of state. The Managing Director shall, in the temporary absence of the Mayor, act as Mayor, pursuant to Charter Section 7-6.

Accordingly, the Council has until March 22, 2020, to approve or disapprove the Mayor's nominees, or the nominees will be deemed appointed.

Your Committee met with 20 of the nominees for the boards and commissions and chose to separate five of the nominees for individual votes.

Your Committee met with Civil Service Commission nominee Colin Yamamoto. Mr. Yamamoto said what he has learned as a trained investigator with the Fire Department will help him as a member of the Civil Service Commission. Mr. Yamamoto also stated now that he has retired, attendance will not be a concern. Mr. Yamamoto said he would

recuse himself from any area where there would be a possible conflict of interest. Your Committee asked that Mr. Yamamoto seek a Board of Ethics advisory opinion prior to the Council considering his nomination.

Your Committee met with Maui Planning Commission nominee Jennifer Salisbury. Dr. Salisbury said her knowledge about things like cesspool conversions and permitting would allow her to make important contributions to the Maui Planning Commission. In addition, she felt it was her duty to contribute to Maui through service, and that working on the Commission would allow her to do this. Your Committee noted Dr. Salisbury's experience and qualifications, but raised concerns about the current makeup of the Commission. Your Committee felt the addition of a developer to the Commission at this time would not be the right choice for the future of the Commission.

Your Committee met with Lanai Planning Commission nominee John Ornellas. Mr. Ornellas stated he has a record of serving as an advocate for Lanai as a past member of several different boards and commissions. Mr. Ornellas discussed his past participation with the Lanai Planning Commission and willingness to work with the rest of the members of the Commission to ensure timely decisions. Your Committee noted he was also an active participant in the community plan process on Lanai.

Your Committee met with Liquor Control Commission nominee Linda Fernandez. Ms. Fernandez stated that as a previous member of the Liquor Control Adjudication Board, she would be interested in being a member of the Liquor Control Commission as the next step in her service to the County. Your Committee appreciates Ms. Fernandez's pervious service, but raised concerns that she was not familiar with the audit of the Department and its recommendations.

Your Committee met with Liquor Control Commission nominee Pedro Venenciano. Mr. Venenciano is currently a member of the Commission, having been appointed to fill a seat vacated by Dawn (Bicoy) Stephenson. Mr. Venenciano stated he had used the time since his

appointment to become more familiar with the operations of the Commission, and anticipated contributing more as time went forward. Your Committee raised concerns about Mr. Venenciano's attendance because he has missed a significant number of meetings in the few months he has been on the Commission.

Your Committee recommended 29 nominees be approved for the boards and terms for which they have been nominated. Your Committee was satisfied with the background of the nominees and expressed its gratitude to the nominees for volunteering to serve the community. Your Committee recommended Exhibit "B" to the proposed resolutions be revised accordingly.

Your Committee recommended disapproval of Jennifer Salisbury to the Maui Planning Commission and Linda Fernandez and Pedro Venenciano to the Liquor Control Commission after conducting deliberations on the nominations. Your Committee recommended Exhibit "C" to the proposed resolutions be revised accordingly.
