The photo was taken from the Blue sun on top of map. When the zip line is operating I hear the noise and screams of all the lines there and I can hear normal conversations and instructions on the platform and even more intense screams.

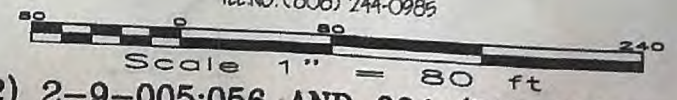

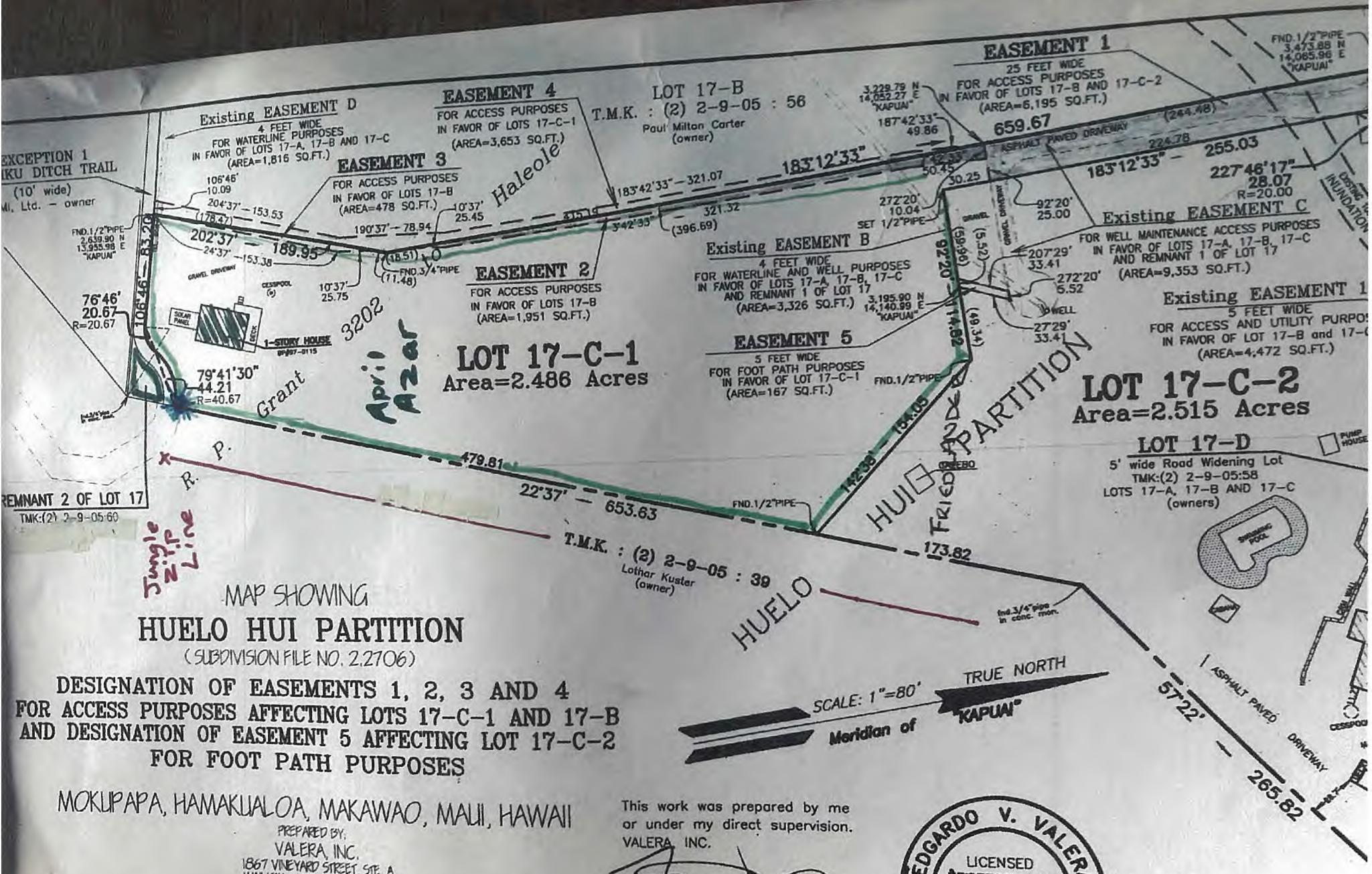

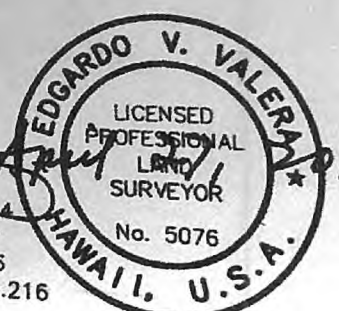
