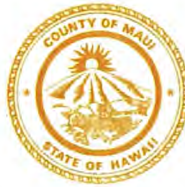

WHEREAS, by correspondence dated May 8, 2020, Mayor Michael P. Victorino notified the Council that he nominated Melissa Padilla to the Liquor Control Adjudication Board for the County of Maui for a term expiring on March 31, 2023, to fill a vacancy replacing Richard Bergson pursuant to Section 2.41.080, Maui County Code ("MCC"), and Sections 8-13.3 and 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"); and

WHEREAS, Section 13-2 of the Charter requires the Mayor's nominees to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

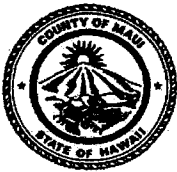
1. That it approves the appointment of Melissa Padilla to serve on the Liquor Control Adjudication Board for a term expiring March 31, 2023;
