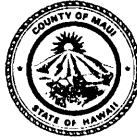

APPROVING THE APPOINTMENT OF

WHEREAS, the Council Chair recommends the Council approve the appointment of April Gragas to fill an Accounts Payable Specialist position in the Office of Council Services; now, therefore,
