BILL NO. 74 (2020)

A BILL FOR AN ORDINANCE AMENDING TITLE 3, MAUI COUNTY CODE,
RELATING TO THE MAUI COUNTY GRANTS PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. The purpose of this ordinance is to minimize barriers for small organizations with limited resources and to maximize the efficient use of County funds for recipients of grants. Many current and potential recipients of grants are community and volunteer-based organizations with limited resources.

SECTION 2. Section 3.36.130, Maui County Code, is amended to read as follows:

“3.36.130 Noncompliance. Any recipient who withholds or omits any material facts, or deliberately misrepresents such facts to the council, the mayor, or any agency, shall be in violation of this chapter. If the agency finds that a recipient has violated this chapter or the terms of its contract, the agency shall inform the mayor who shall inform the council in writing, and[, upon council concurrence, the recipient shall be prohibited] the council may then by resolution prohibit the recipient from applying for any grant for five years following such finding, require the recipient to return all funds or real property granted to the recipient, and require the recipient to be subject to debarment proceedings.”


SECTION 3. Chapter 3.36, Maui County Code, is amended by adding a new section to be appropriately designated and to read as follows:

“3.36.190 Disbursement. Recipients of grants are eligible for upfront disbursement of 25 percent or more of grant funds, and any remaining grant funds must be paid through the agency's reimbursement process.”

SECTION 4. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 5. This ordinance takes effect on July 1, 2020.
