# Resolution

PROPOSING AN AMENDMENT TO THE  
REVISED CHARTER OF THE COUNTY OF MAUI  
(1983), AS AMENDED, RELATING TO OFFICE  
OF COUNCIL SERVICES STAFF

BE IT RESOLVED by the Council of the County of Maui:

1. That, in accordance with Section 14-1, Revised Charter of the County of Maui (1983), as amended ("Charter"), it proposes that Subsection 1 of Section 3-7 of the Charter, pertaining to Office of Council Services, be amended to read as follows:

"1. There ~~[shall be]~~ is an office of council services~~[.]~~, which is headed by a director of council services. ~~[The council may create such positions in the office of council services as it deems necessary to assist in the exercise of its legislative power. The salaries of such positions shall be fixed by ordinance.]~~ The director of council services and a supervising legislative attorney within the office of council services must be appointed and removed by the council by resolution. The director of council services has sole authority to appoint and remove all other staff. Persons appointed to such positions by the ~~[council shall be]~~ director of council services are exempt from civil service~~[.]~~ and serve at the pleasure of the director."; and

2. That material to be repealed is bracketed and new material is underscored; and

3. That, in accordance with Subsection 1 of Section 14-2 of the Charter, this Resolution be submitted to the voters of the County of Maui at the next General Election; and

4. That the County Clerk prepare the necessary ballot for presentation to the voters at the next General Election; and

5. That, in accordance with Section 14-1 of the Charter, it hereby proposes that the following question be placed on the next General Election ballot:


“Shall the Charter be amended, effective January 2, 2021, to authorize the Council to appoint and remove a Director of Council Services and a Supervising Legislative Attorney by resolution, and authorize the Director of Council Services to appoint and remove other necessary staff in the Office of Council Services?”; and

6. That, in accordance with Subsection 2 of Section 14-2 of the Charter, the County Clerk publish the proposed amendment as set forth in this Resolution in its entirety in a newspaper of general circulation; and

7. That, if approved by the majority of the voters voting on the proposed amendment, the amendment proposed by this Resolution will take effect on January 2, 2021; and

8. That certified copies of this Resolution be transmitted to the Mayor, Corporation Counsel, and Director of Council Services.
