Chair and Members:

Your Environmental, Agricultural, and Cultural Preservation Committee, having met on June 16, 2020, makes reference to County Communication 20-298, from Council Vice-Chair Keani N.W. Rawlins-Fernandez, transmitting a proposed resolution entitled "ESTABLISHING THE MĀLAMA MAUI COUNTY PLEDGE."

The purpose of the proposed resolution is to provide visitors with clear guidelines to demonstrate their commitment to appropriate, respectful, and safe behavior when visiting any of the islands within Maui County through the establishment of the Mālama Maui County Pledge.

Your Committee reviewed the resolution and expressed support for the pledge.

Your Committee discussed the need to extend the resolution's reach to increase awareness of the pledge and to increase the potential for collaboration with visitor and government agencies.

Your Committee revised the proposed resolution by amending Hawaiian words to increase their accuracy.

In addition, your Committee added a clause to recognize the Maui Visitors Bureau's education efforts as Maui County's visitor accommodations prepare to welcome back visitors.

Your Committee also added language to encourage operators of hotels and vacation rentals to have their guests sign the pledge and to

ESTABLISHING THE MĀLAMA MAUI COUNTY PLEDGE

WHEREAS, visitors to Maui County need clear guidance on appropriate, respectful, and safe behavior when visiting any of the islands within Maui County; and

WHEREAS, Maui County's visitors also need a mechanism to demonstrate their commitment to engaging in behavior that is safe to themselves and acknowledging our rich local history, culture, and environment; and

WHEREAS, the Republic of Palau and Hawai'i County have visitor pledges that outline a visitor's commitment to proper behavior while on vacation; and

WHEREAS, the Maui Visitors Bureau seeks to educate and inform visitors to our islands as we begin to welcome guests back to the islands, and this pledge is a good step in that work; and

WHEREAS, a visitor pledge would help Maui County's visitors understand how they are expected to behave; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That the following is established as the Mālama Maui County Pledge:

I pledge to ho'oma'ema'e (do what is right) while visiting the islands and waters of Maui County.

I will mindfully experience the breathtaking natural beauty of the 'āina (land) and the welcoming aloha spirit of its po'e (people).

I will be ha'aha'a (humble) and no'ono'o (thoughtful) in my actions.

I will remember that each step I take is upon land that is someone else's home, sacred site, and living history.

If I do not know proper, respectful, or safe behavior, it is my kuleana (responsibility) to 'imi na'auao (seek knowledge) and ask before acting.

I will be maka'ala (aware) while swimming and hiking, and I will respect the strength and power of ocean currents, rushing streams and the variable and unfamiliar terrain of these islands.

I will admire wildlife from a safe and respectful distance, as Hawai'i is the endangered species capital of the world.

I will take nothing from this wahi (place) but memories and leave nothing but gratitude.

I pledge to mālama (take care of) Maui County, and remember that:

He ali'i ka 'āina; he kauā ke kanaka. "The land is a chief; man is its servant."; and

- 2. That it encourages the Maui Visitors Bureau to work with the Hawai'i Tourism Authority and airline partners to furnish the pledge for signing, along with other customs declarations forms, before landing; and
- 3. That activity businesses that hold County permits to operate on public lands or in our nearshore waters are encouraged to have their customers and guests sign the pledge to show their respect for our precious resources; and
- 4. That it also encourages display of the pledge in as many spaces throughout Maui County as possible to serve as reminders of responsibility and etiquette for both our visitors and residents; and
- 5. That certified copies of this resolution be transmitted to the Honorable Brian E. Schatz, Senator, United States of America; the Honorable Mazie K. Hirono, Senator, United States of America; the Honorable Ed Case, Representative, United States of America; the Honorable Tulsi Gabbard, Representative, United States of America; the Honorable David Y.
