Pursuant to your letter dated September 3, 2020, relating to the Requests/Questions from the August 25, 2020 Meeting, below are the responses to the following:

1. The total number of rental motor vehicles in Maui County, currently and pre-pandemic, from 2017 through 2019, further broken down by island (Maui, Molokai, and Lanai).

Response: The Division of Motor Vehicles & Licensing (DMVL) is unable to provide this information. The DMVL does not have the resources nor computer system to compile the number of rental vehicles. However, based on a telephone survey of the major rental companies on Maui, prior to the COVID-19 pandemic, the estimate is approximately 22,000 rental vehicles. It is important to note that some of the rental companies were very reluctant in providing exact numbers as it would have divulged their proprietary market

share information. Additionally, there may also various smaller rental companies who rent used vehicles.

2. Impacts to County revenue if the number of rental motor vehicles in Maui County were capped. Please project revenue impacts based on an incremental decrease of rental motor vehicles (for example, based on every 100 cars, 1000 cars, etc.).

Response: Please refer to the attached projected revenue impacts based on incremental decrease of rental motor vehicles. The revenues are based upon an estimated 2,900 pound average weight of a passenger vehicle.

3. The Department of Finance's comments on the proposed State bill.

Response: The Department understands the intent of the Committee and does not have any comments at this time.
