Dear Legislators and Council Members,

As a resident of Maui and as a mother of a small child, I need to voice some thoughts regarding certain measures that might be taken in order to protect us from the ongoing spread of Covid-19. I am deeply concerned about our health here in Hawaii. During Governor Ige's 4/29 update, he voiced that HI wants to attract the kind of visitors we want here in the healthiest state of the US that we have created! That is what we want too! According to Atty General Barr 4/27/2020:

"If a state or local ordinance crosses the line from an appropriate exercise of authority to stop the spread of COVID-19 into an overbearing infringement of constitutional and statutory protections, the Department of Justice may have an obligation to address that overreach in federal court."

SB75 SD2 seems to open a few doors towards forced testing as well as mandatory vaccination.

Please hear me well. I do not consent to mandates vaccines in any scenario! Every human being has the constitutional right to choose what they have injected into their bodies. Vaccines are necessary and helpful in many ways. The desperately awaited vaccine for covid-19 though, is not on the market yet. In light of information today, as in the www.npr.org article, "INFECTIOUS DISEASE Mutant Strains Of Polio Vaccine Now Cause More Paralysis Than Wild Polio

June 28, 2017 3:22 PM ET", it is no longer acceptable to force the American people, who are supposed to be 'endowed with certain inalienable rights' such as 'life, liberty and the pursuit of happiness' according to our Declaration of Independence, to submit to vaccines against their will, which violates both liberty and life, as stated in The Indian Journal of Medical Ethics regarding the death of girls who received a Human Papilloma Virus vaccine from an American Foundation. Petition is to overturn all policies allowing mandatory vaccines & disallow mandatory micro chipping or skin I.D.'s even in states of emergency & declarations of war.

In 1986 the Supreme Court stated that "Vaccines are unavoidable unsafe" and created the "National Childhood Vaccine Injury Act" which released vaccine manufacturers from ANY liability. But it is to protect the vaccine industry from an overload of lawsuits that would unavoidable occur (and indeed did before 1986). In addition to this I want you to know that the National Vaccine Injury Compensation Programs payouts for vaccine injuries already went past the \$4 billion mark. Using the government's own conclusion that only 1% of all vaccine injuries are reported (<https://digital.ahrq.gov/sites/default/files/docs/publication/r18hs017045-lazarus-final-report-2011.pdf>), the \$4 billion is just the tip of the iceberg. Despite assurances from CDC and our Federal agencies that all vaccines are safe, the payouts say otherwise. Vaccine injuries can and do happen. With this said, the statement "Vaccines are safe and effective" is obviously untrue.

As I said before, I think vaccines are a great intervention, when tested and used in the right way. In our particular situation, we can not aim to mandate a vaccine that is still in development and won't be tested properly. As we just learned, vaccines come with risks and where there is a risk, there must be a choice. We all want the best for our families and especially for our

children. There must be other ways than forcing a risky procedure onto school children, healthcare workers, teachers, travelers and other groups that will be the first ones to be targeted.

As a business owner here on Maui, I also want to voice a concern that is regarding our local economy. With what we know about the future Covid-19 vaccine and how it won't be tested properly, I'm quite certain, that many travelers will choose another destination for their vacation, if they have to get this shot in order to come to our beautiful islands. More and more people are aware of the risks this vaccine will come with and won't choose Hawaii over the health of their families.

In these uncertain and scary times, I urge you to listen to your heart and do what's humane and according to the constitution and our bill of rights. Be the one who stands up for the people. Choose health over pharmaceuticals.
