BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5099, Bill No. 64 (2020), Draft 1, as amended, "Fiscal Year 2021 Budget", Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2021, is hereby as it pertains to the Department of Water Supply, by adding a new appropriation entitled "State of Hawaii, Kanaha Beach Park Greywater Reuse Demonstration Project" in the amount of \$450,000, to read as follows:

"13. Department of Water Supply

a. State of Hawaii, Department of Land and Natural Resources	1,000,000
b. <u>State of Hawaii, Kanaha Beach Park Greywater Reuse Demonstration Project</u>	<u>450,000"</u>
