A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.56, MAUI COUNTY
CODE, RELATING TO BOARD OF ETHICS ADVISORY OPINIONS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 2.56, Maui County Code, is amended by adding a
new section to be appropriately designated and to read as follows:

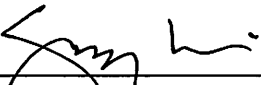
**“2.56.070 Board of ethics advisory opinions. A. To the extent
permitted by law, all advisory opinions rendered by the board of
ethics pursuant to Article 10, Revised Charter of the County of
Maui (1983), as amended, shall be posted on the County’s website
within thirty calendar days from the date of the opinion.**

**B. Advisory opinions rendered prior to the effective date of
this ordinance shall be posted on the County’s website within a
reasonable amount of time.”**

SECTION 2. New material is underscored. In printing this bill, the County
Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.
