This email will be one of thousands to bring attention to and to stop the illegal denuding, destruction, and disrespect being done to the land makai and mauka in Olowalu.

I am a healthcare professional serving Maui County for 23 years. Born in East Maui. Living in Lahaina. We do NOT want Liahua'ula development.

It is absolutely DISGUSTING allowin Peter Martin, Glenn Tremble, et al to desecrate and destroy public land in Olowalu. They are currently engaged in ground altering activities. Installing sprinkler systems on public land, blocking shoreline access, dumping construction rubbish on the shoreline.

They are clearing land without permits on PUBLIC LAND in Olowalu. Conservation permits do NOT allow this type of land clearing on state conservation land.

They ILLEGALLY denuded land by historic site 4694. They did not protect the site itself according to GCPs. They dump broken concrete and refuse directly on the shoreline.

The clear cutting of trees at Camp Olowalu is ILLEGAL. We Do NOT want this. This all adds to the crisis of the health of our land and reefs
We want this land replanted.

They cut all the trees in Olowalu down which allows sediment into the ocean destroying our largest and most vital reef in all of Hawaii.

We do NOT want Liahua development. We do not want 201H developments that allow gentleman estates to be brought through the back door.

We do NOT want Liahua development.

The land near the Olowalu Recycling and Refuse Center is being ILLEGALLY cleared. This is toxic to our land. It permanently destroys the balance allowing chemicals, toxins, pesticides, sediment into the ocean. Killing our reefs and the things the tourists come to see.
